High-level introduction to the history of the CRT and where we are now in the planning process. Additional meetings are allocated to this topic, with the next occurring on CMLWG meeting no. 3 (September 29, 2016).

Desired outcome: The CMLWG will be eventually providing input on the CRT in terms of design and location, with the exception of 39 C, South (Santa Fe to Chesterfield). At this meeting, group to determine if walking tours would be helpful, which would be scheduled in advance of meeting no. 3.
