Public Engagement Visioning Activities: Parking-Related Comments & Survey Results

Stakeholder outreach was conducted during between October 2016 and December 2016. Outreach consisted of a combination of mail-in household surveys, internet-based household surveys, in-person intercept surveys, online business surveys, stakeholder meetings and comments. In addition to obtaining quantifiable data, each of these events provided an opportunity for Encinitas residents to provide openended comments. The following summarizes the survey results and comments received, organized by each survey question, as well as the comments received during stakeholder meetings. Please note that the comments have been entered directly as they were received from the public and have not been altered in any way.

Public Meeting Comments:

These comments were received over three public meetings held between October 5, 2016 and October 8, 2016. The public meetings were held in an open house style, with various stations where the public was informed and could give input on the various components of the Coastal Mobility and Livability Study.

- Parking within this area (Coastal Corridor) is packet during nights.
- Bike/Ped lanes should be grade-separated (2"-4"?) along Vulcan Avenue and the railroad right-of-way.
- Vulcan Avenue, Leucadia Boulevard, and La Costa Avenue: inadequate parking for large apartment buildings. Parking occurs in the railroad right-of-way (illegal?). The same problem exists on Coast Highway – people also park in the railroad right-of-way on the east side of Highway 101. It is essential for businesses to have parking.
- Underground the railroad tracks and put parking on top.
- Private parking lots are generally full.
- Leverage before double-track.
- Current parking issues (Hwy 101) impede public safety, pedestrian access to retail and restaurants, beaches, etc.
- NCTD should weigh in on the legality of parking along the railroad right-of-way. Is this a problem?
- Are NCTD (railroad right-of-way) parking spaces truly viable for future planning?
- How could one work with the NCTD right-of-way?
- It is a flaw to count NCTD land for parking.
- Define the first criteria of NCTD.
- Emphasize micro-lass transit and bikes.
- How to solve for future parkway in community parking?
- Offer a bonus density incentive for underground parking structures.
- No change to the shuttle.
- Build a parking structure at the train station.
- Angled parking along Hwy 101 on west side?
- Build a parking garage downtown
- Place Fire Station #1 on Moonlight Beach and put parking under.
- No meters.
- Look at Encinitas Elementary
- Think about the School Buses



Business Survey Results:

A mail-in business survey, consisting of 14 questions and two open-ended opportunities for additional comment. The following provides a summary of the survey results, followed by the additional written comments provided by the survey takers.


Question 1: Please select one option that best represents you as it relates to the place of business.



Of the 92 respondents, the majority identified themselves as a business owner (65 people), followed by an employee of the business surveyed (17 people), and property and business owners (10 people).








Of the 92 total responses, surveys were most commonly received from Leucadia (43 surveys), followed by Old Encinitas (37 surveys) and Cardiff (12 surveys).

Question 3: Where do you typically park your car along the Coast Highway 101 Corridor and the beach neighborhoods? (check all that apply)



A majority of the 93 responses of to this question indicate that a business' own parking lot is the most common place for business owners and/or employees to park, followed by street parking, with 51 and 48 responses, respectively.




Question 4: To keep prime parking spots open for customers or shoppers, have you or other employees of your business/work been instructed or asked to park cars away from primary business areas?



A majority, or 65 of the 92 respondents, indicated that employees park away from primary business areas in order to preserve parking for customers.


Question 5: On most days/nights, how many of your employees/workers use the remote or alternative location rather than the prime parking spot?



It was most commonly found that all or nearly all employees park in remote or alternative locations most days and nights, garnering a 32 of the 68 total responses received.




In Cardiff, among those businesses that are located in the community or serve/visit the area on a regular basis, it was most commonly reported that spots are hard to find between the hours of 11am – 7pm. From 8am – 11am and 7pm – 11pm, it was most commonly reported that one can usually find a parking space.


In Old Encinitas, among those businesses that are located in the community or serve/visit the area on a



regular basis, it was most commonly reported that it can be hard to find a parking space across all times of the day, with a notable majority of respondents indicating the difficulty of parking between 11am – 7pm.

In Leucadia, among those businesses that are located in the community or serve/visit the area on a regular basis, it was most commonly reported that it can be hard to find a parking space during all times of the day.




Question 9: Do you think your customers or shoppers would visit your business/work more often if parking was easier to find?



Of the 90 responses received, a majority, or 64 people, indicated that they believe customers would visit their business more often if parking were easier to find.

Question 10: What do you see as the biggest obstacles with parking in your area (Select all that apply):



Respondents commonly indicated that a lack of parking, followed by the demand for parking during peak business hours, were the primary obstacles to parking in the Coastal Corridor.



Question 11: For the customers or shoppers that use cars to get to your business/work, how long do your customers or shoppers typically park their car there at the location?



Businesses indicated that customers most commonly park between 1 and 2 hours, followed by those that park for less than 1 hour, garnering 27 and 26 of the 86 total responses received to this question, respectively.

Question 12: Please select what you consider to be the biggest challenge(s) for parking in the Coast Highway 101 Corridor and Beach neighborhoods? (Check all that apply)



Finding an available space quickly, followed by finding an available space close to one's destination, were indicated to be the biggest challenges to parking in the Coastal Corridor.




Question 13: Would you be willing to support paid parking alternatives in the Coast Highway 101 Corridor and Beach areas if it meant a space would always be readily available for your customers?



In each of the Coastal Corridor communities, the majority of respondents indicated that they would not support paid parking alternatives, even if it guaranteed a readily available space.

Question 14: How would you encourage alternative transportation modes?



Business owners expressed a slight preference toward supporting alternative transportation for employees and co-workers rather than for customers, with 38 and 30 responses, respectively.



Household Survey:

A household survey was administered to residents of Encinitas to support the intercept survey effort, and to see if Encinitas residents have similar viewpoints to the intercept survey participants, noting that most did not live in the City of Encinitas. Household surveys consisted of 16 questions, and were administered in two formats – online and via US Mail.


Question 1: Where do you live?



Of the 498 responses received, the Highway 101 communities of Leucadia, Old Encinitas, and Cardiff replied at the highest rate, with 178, 137, and 86 replies, respectively, compared with 36 responses from residents in New Encinitas, 52 responses from residents in Olivenhain, and 9 responses from residents in other locales.




Question 2: How often do you typically go to the following neighborhoods in the Highway 101 Corridor and beach areas?



Residents were found most commonly to visit each of the three Coastal Corridor neighborhoods multiple times a week, compared to less frequently.

Question 3: What are the typical reasons for visiting the following neighborhoods?



Residents most commonly cited visiting a business as the reason for visiting each of the Coastal Corridor communities, followed by recreation, and being a resident of the community in question.






Question 4: How long do you typically stay at the Coastal Corridor?

Of the 655 responses received, residents most commonly reported spending 1-2 hours at the Coastal Corridor (251 responses), followed by 2-4 hours (192 responses) and 4+ hours (119 responses).


Question 5: When visiting the Highway 101 Corridor and beach areas, how much money do you usually spend per trip?



In Cardiff, residents most commonly reported spending between \$0 and \$25 (226 responses), followed by \$26 and \$50 (163 responses). In Downtown Encinitas, residents most commonly reported spending between \$26 and \$50 (211 responses), followed by \$51 and \$75 (145 responses). In Leucadia, residents most commonly reported spending between \$0 and \$25 (224 responses), followed by \$26 to \$50 (164 responses).




Question 6: When using a car, where do you typically park Highway 101 Corridor and beach neighborhoods? (Check all that apply)




Of the 1,035 responses received, 511 report typically parking on the street. A further 300 use business parking lots, 82 use the open space in the rail right-of-way, 71 use a personal garage or driveway, 68 use public parking lots, and 3 use other parking options, such as designated handicapped parking.

Question 7: How would you describe the availability of parking within the Highway 101 Corridor and beach neighborhoods?






Question 8: Would you visit the Highway 101 and beach neighborhoods more often if parking was easier to find?



Question 9: Would you use a shuttle to access the neighborhoods if it was available?




Question 10: Do you ever take ride services such as Uber or Lyft to the Highway 101 Corridor and beach areas?





A total of 642 responses were received for this question. A majority of respondents (409 people) indicated that they had not previously used rideshare services to travel to the Highway 101 Corridor and beach areas.


Question 11: If you had to pick one, what mode of travel do you most often utilize to access different destinations within the Coastal Corridor?



A total of 648 responses to this question were received. The most popular method of accessing destinations along the Coastal Corridor is by driving alone, with 393 respondents. The next most popular methods of travel were walking (96 respondents), followed by carpooling (86 respondents).

Question 12: Are you willing to walk/bike from your home or parking spot to your destination?





Of the 649 responses to this question that were received, many individuals showed a willingness to walk distances of greater than 6 blocks (201 people). A similar number of people expressed a willingness to walk short distances of a few blocks as those who prefer to park directly at their destination (153 people). Slightly fewer people expressed a willingness to walk a moderate distance of 3-6 blocks (142 people).


Question 13: Would you Walk or Bike if there were Safer Facilities?



Of the 406 responses to this question that were received, a majority of individuals (250 people) expressed a willingness to walk or bike more if facilities were safer, compared to 156 people who replied that safer facilities would not likely motivate them to walk or bike more.



Question 14: What would be the most important thing to get you to use active transportation, like walking and biking?




Of the 199 replies to this question that were received, a significant majority expressed that the presence of safer facilities would be the most important component to encouraging greater utilization of active modes of travel. The second most popular response, garnering 46 replies, pertained to other, non-named strategies.

Question 16: Please select what you consider to be the biggest challenge(s) for parking in the Highway 101 Corridor and beach neighborhoods? (Check all that apply)



Of the 816 responses to this question that were received, a total of 319 people felt that finding an available parking space close to their destination was the greatest challenge for Coastal Corridor communities, followed by finding a space quickly (280 responses) parking and exiting one's vehicle in a safe manner (141 responses), and knowing where parking is legal and allowed (76 responses).

Additional written Comments Form the Survey:

Question 2: How often do you typically go to the following neighborhoods in the Highway 101 Corridor and beach areas? (Additional thoughts):

- Parking along Leucadia's 101 corridor is difficult and confusing. The parking along the east side
 of the 101 along the tracks needs to be organized. There should be pedestrian crossings at the
 cross streets on the 101 i.e. Jasper St Coast Highway parking should have a 2-hour time limit.
 There are many cars parked along the corridor for 10-12 hours, sometimes even days.
- Need more lanes of traffic and parking downtown, not less, so route bicycles, especially the large groups to 2nd or 3rd street
- Need a walkable link between all three coastal communities and ideally beyond to Solana Beach and Carlsbad
- Need access across our railroad tracks and parking. Trench and cover our railroad for the best long term solution.
- There are a lot of cars, too many.2) Our coastal towns are used as I-5 cut through roads, harming our quality of life.
- I have additional thoughts re the below q on typical reasons for visiting the corridor. It won't allow the checking of multiple boxes, but if it would i would have checked almost all boxes for Leucadia and Downtown Encinitas.
- Complete each intersection, i.e., provide crosswalks on all four sides.



- My family and I visit the corridor as a family less, and less because it is busy, and not family friendly. Seems like it's more important to build tax revenue than it is to provide a good experience to residents.
- I live in coastal Leucadia
- I live, work and am most often in Leucadia. I often eat out or go out in Downtown Encinitas. I also go out often in Cardiff. Majority of my time is spent in Leucadia on Vulcan (aka the wrong side of the tracks).
- Also, often go to Ponto Beach in Carlsbad.
- We need an easy/safe way to bike to the coast.
- I live in Leucadia. I tried to give multiple reasons in question 2, but it wouldn't let me toggle on more than one for each area??!!...
- Leucadia is the only area above that, in addition to having no railroad crossing, has very little public pathways or crossings even on the 101 (yet somehow has bus stops on the railroad side of the 101 without legal crossings).
- Will object to paid parking
- Traffic travels a bit fast, but it is a classic thoroughfare
- We live on the Corridor
- There's never enough parking. When I try to eat at the restaurants in Cardiff, we have to park blocks away in the residential areas and circle to find a spot. Downtown Encinitas is the same, depending what time of day you go. There's very limited parking. They need a parking structure or two.

- Adequate parking is more important to quality of life than traffic volume! Please stop underestimating parking needs at destinations such as parks, beaches, restaurants, libraries, shopping, etc. Tourist destinations need MORE parking than required by code!
- I live a short walk from a beach access in Leucadia, so the questions below don't apply to me. It sounds as if the purpose of the study is to get more people to come to the coast. Is the group dominated by business owners in the 101 corridor?
- Leucadia Blvd is getting VERY CONGESTED, especially on weekends.
- My main concern is making it more pleasant and safe to use a bicycle for transportation. I would like to see more paved bicycle paths, bigger dedicated bike lanes and more traffic calming measures such as speed bumps. Sharrows aren't much of a help.
- I just moved here in Leucadia area in Encinitas
- Our area needs safer bicycle path/roads/lanes and sidewalks need to be wider. It difficult walk side by side with your partner along them.
- Do not take away parking or make vehicular travel any worse. Provide bicycle & pedestrian
 access on secondary streets and not on major thoroughfares like Coast Hwy 101, El Camino
 Real, Encinitas Blvd.
- The Leucadia Blvd. and 101 intersection is very bad. It normally takes 5-10 minutes to wait through the lights b/c of how it is set up with the two streets. It's a major clog up of traffic.
- I enjoy the vintage coastal appeal of these communities.
- I frequently travel to Best Buy, which is on El Camino Real @ Leucadia Blvd NOT downtown Encinitas
- Traffic is tough when driving on 101, especially when making left hand turns at the stop lights.
- the street is too crowded, mixing the bicycles and autos in the same lanes
- Leucadia is where I live, work, and play.
- Love it how it is
- I would go north to Downtown Encinitas much more often, but it is unsafe for me to do so by walking or biking from Cardiff
- Keep lanes open and traffic moving. There are not many ways to get downtown from where I live
 east of the freeway. Do not take major thoroughfares down to one lane. There must be 2 lanes for
 traffic flow.
- Beach, walking, restaurants, sunsets



- I live in Cardiff and run on the trails near bluffs. I don't think making a paved "trail" would help any part of our beautiful natural space. Cyclists won't use it, because it doesn't connect to long, uninterrupted bike lanes...if you're a real runner you want to run on naturally created trails!
- Leucadia is mostly too junky and has terrible parking.
- I prefer to either walk or bicycle when going into Cardiff or downtown Encinitas
- I also go to Solana Beach and occasionally Carlsbad because I can take the Coaster. Cardiff and Leucadia require driving, so I rarely go.
- We need connectivity along the entire rail corridor, connecting people and places.
- Put the new Coastal Rail Trail on coast Hwy.
- I also bike and walk to these areas
- I should be able to check more options below. Not only am I a business owner, but my kids surf Cardiff/seaside every weekend.
- The light at the 101 and Chesterfield gets extremely backed up on the N and S bound route in Cardiff.
- I usually walk
- I drive because I live east of I-5 and the Railroad. Walking or biking past these barriers is dangerous and the hills around here make it difficult.
- No problems and do not wish for the city to make improvements
- About what?
- Would like to go to Cardiff & Leucadia by foot more often.

Question 9: How would you describe the availability of parking within the Highway 101 Corridor and beach neighborhoods? (Additional thoughts):

Leucadia: garage

- Need more disabled parking to access more businesses
- A lot of out of town residents who dart across the 101 in Leucadia, making it very dangerous.
- Parking sucks. It's faster for me to walk fifteen minutes from home for coffee than drive two
 minutes and try to find a spot
- No more trailers/RV on the Hwy 101 in Cardiff Parked!! -> Go to the campgrounds
- Totally depends on the day and time and season!
- This is the main reason why we avoid going to these areas parking takes too long to find
- In Leucadia, it's easier because not as busy.
- I can usually find a parking space in Cardiff except in the Summer.
- In downtown along 101. Old downtown or El Camino Real downtown.
- The Leucadia restaurants like Papagayo, Regal Seagull and Solterra should consider a valet service on weekends.
- Need more parking
- Spending money on short term solutions is a waste. Trench and cover the railroad tracks for safety and environmental needs.
- Keeping the rail right-of-way available for parking is very important, especially in Leucadia.
- We need more public transportation to allow us to cruise the coastal corridor (trolley) and bike share (rentals).2) More parking lots and places for more cars will ruin our coastal corridor (blight, traffic, emissions, stress).
- We need more parking along the rail right of way and many crossings. A crossing half way between La Costa and Leucadia is needed (not just a Grandview which is too close to La Costa and too far from restaurants, etc. to be beneficial).
- Since I live in Leucadia, I generally try to avoid driving a car to destinations in Leucadia or downtown Encinitas.
- Better permitting of restaurants and growth. If there isn't enough REAL parking available without adding it, a business or residence shouldn't be permitted. Or, enforce the rules better.
- In Leucadia, I typically park in the dirt along the train tracks even though that is technically not legal. There is limited parking otherwise and parking here makes the most sense.



- I'm against adding more parking spaces in Old Encinitas or Cardiff. No parking garages! Adding parking just encourages more people to drive cars. Cars add to the congestion. More cars are dangerous, too many people are distracted while driving now with their smartphones. More people are using Uber and Lyft. Better to add bike racks and promote public transportation.
- Downtown Encinitas probably has the worst parking situation. It is almost always hard to find a parking spot, and nearly impossible to find one on the 101. Even the coaster station parking lots are usually full (by D Street and E Street). I work in Leucadia so I am always able to find a parking spot at my place of employment which is so great. I usually can find parking at Regal Seagull, but parking for Papagayo or Haggo's or Fish 101 can be really hard. Cardiff is hit or miss, but most often miss. If you're going out to bars off Vulcan/San Elijo you may get lucky. It's usually impossible to find a spot at Pipes. On the 101 in Cardiff it is always impossible to find a parking space unless you're going to a place that has a parking lot. Even then it can be a challenge (Las Olas).
- I have opted out of many town events because of poor parking availability.
- Could not select more than one option in prior question "What are the typical reasons for visiting
 the Highway 101 Corridor and Beach neighborhoods? (check multiple if needed)" My family and I
 regularly eat, shop, use the beaches/parks, practice yoga in Downtown Encinitas which is why we
 moved here from La Costa Oaks this past January.
- Please leave the rail right of way between Santa Fe and Birmingham available for parking and
 enjoyment of a beautiful, natural area. Please do not pave or fence off this wild and scenic stretch
 of land in the heart of our community. This is what gives Encinitas character, and distinguishes us
 from Del Mar or Orange County. Please leave this tiny expanse of urban wilderness for current
 and future generations to enjoy.
- Sometimes is difficult to find parking in Encinitas on weekends.
- The "Check all that apply" option isn't working. I can only check one. I'm using Chrome on a Mac.
- I walk to the corridor more than driving, so I don't need to occupy a parking spot.
- I can always find a space. Sometimes it is a few blocks away or on a side street but I enjoy walking in those areas anyways so it is no big deal.
- Parking downtown Encinitas is almost impossible day or evening. I avoid stores downtown for this very reason. I propose the city construct a parking structure on the property between D & E streets on Vulcan. This should be a multi-story garage rising up to City Hall. There should be an hourly charge to park within the structure. Verified Encinitas residents could purchase an annual pass to park anywhere downtown. (Parking meters for street parking on 1st Street might also be considered.) I believe the downtown merchants would welcome this additional parking. Because of the location of the structure, shoppers and diners would have to walk to their destination on 1st street. When one walks they pass other stores that they, perhaps, have not noticed previously. Increased foot traffic is extremely beneficial for merchants. Parking structures are expensive. With fee based parking (both permits for residents and cash for visitors) and an increase in business license fees, revenue could be generated to help mitigate the cost.
- I would love to be able to bike and walk more easily and to take the bus and for my children to do the same. There are not enough rail crossings in Leucadia and biking along Vulcan and the 101 doesn't feel that safe. Also, crossing Vulcan and the 101 is not safe as a pedestrian. I would love for there to be a regular/timely local bus system along the corridor (say, a but every 5-10mins). A bus system would seem like an obvious relatively cheap way to improve access and mobility for all ages and socio-economic ranges especially if you made it free for kids and seniors!!....
- The Hillcrest / Grandview location desperately needs a legal railroad crossing. It is a growing residential area, has multiple commercial and beaches nearby, and has no viable crossings for either the railroad or 101 for miles. This is also a liability issue for the City, since they have positioned bus stops at areas with no viable access to those stops (thereby encouraging people to cross both the rail and the 101 illegally). This needs to be addressed, and it is a much greater urgency than any of the other proposed sites since those sites are closer to alternative access points.



- I have lived here over 30 years and seen it change dramatically. Parking is haphazard and there is an increasing need due to the amount of development. We need to build a parking structure under the Moonlight Beach Parking Lot like they did at the San Diego county building downtown.
- Make improvements to the rail right of way to allow for more parking and less flooding with the rains
- PLEASE DO NOT CONVERT THE 101 INTO A MASSIVE PARKING AREA. If we want to minimize cars we should encourage other modes of transport, not MORE cars.
- The Leucadia rail corridor/N. Vulcan is a disaster. Both the 101/Vulcan should be repaved with
 paved angled parking spots, bike lane, pedestrian lane/sidewalk -- the parking can be metered to
 pay for improvement. I am sure NCTD would be ok with splitting the money brought in by
 parking.
- I usually ride my bike or walk so parking is not an issue.
- I can always find a parking spot. I don't think the coastal corridor has a parking problem but rather
 an accessibility problem which makes cars the only way for a lot of Encinitas residents to enjoy
 the coastal corridor. I don't think parking should be pitted against creating bike lanes, walking
 trails or accessibility amenities that will make biking and walking just as logical and as safe as
 driving.
- Your survey will not allow me to choose multiple answers even when you tell me to check multiple answers, if necessary.
- Can always find a parking spot if you're willing to walk far enough!
- I live on Jasper Street, and there is no parking EVER for the residents that live on that street, as the businesses along the 101 Corridor there take them all. It has become unbearable!
- NO PAY PARKING!
- This survey says "check all that apply" on certain questions but will not allow me to check more than 1 answer!!!
- I try to time my visits to off peak hours.
- FYI, in the survey so far, wherever the question asks to "check all answers that apply", I've only been allowed to check one answer. Therefore some selections could not be made, leading to incomplete answers.
- Please keep parking free in Encinitas!
- The survey does not let you pick multiple answers in the questions where that is an option, FYI.
- Cycling on 101 between Del Mar and Leucadia is dangerous! I would like to see a dedicated, paved bike path between these towns.
- I can't wait to get to see & know the area here in Encinitas and check out the Highway 101
 Corridor and Beach Neighborhoods
- I can't check all that apply in questions: What are the typical reasons for visiting the Highway 101 Corridor and Beach neighborhoods? (check multiple if needed) I would like to choose Visiting a business + Recreation + Visiting a Resident When using a car, where do you typically park Highway 101 Corridor and beach neighborhoods? (Check all that apply) I mostly park on the street then on public parking lot I don't find it hard to park but I don't mind walking a bit. Everything is close anyway.
- The train tracks sides would be a great parking location along the 101
- State Parks access should be in survey.
- The Typical Reasons for Visiting question above will not let me put multiple answers I would have chosen more if I could.
- I think parking is dangerous for everyone because drivers are stopping in streets, traffic cannot flow, crosswalks and sidewalks are not meeting our needs and we have to constantly cross the tracks
- I'd like to walk there, but it's difficult. The 5 underpass at Encinitas Blvd. is treacherous!
- Your survey is not working properly. For those items like What are the typical reasons for visiting

 the typical reasons for visiting the Highway 101 Corridor and Beach neighborhoods? (check
 multiple if needed) you can't input multiple answers. Fix your survey and send it out again.



- provide more free public street parking and do not remove any for bike lanes.
- Parking along the 101 can be kind of dangerous with cars coming full speed and having to stop in the lane and parallel park in the face of oncoming traffic in Leucadia.
- I prefer the 101 area to stay quaint. I do not wish to see it built up with 48' tall buildings. Traffic in the area, especially El Camino Real and Olivenhain is bad. More businesses and residents mean more traffic. I don't believe the current plan, prop T, is an answer to affordable housing. Believe it is siding with the developers not the residents of Encinitas.
- When we are visiting the beach, we will most likely use our State Parks pass to park in the lots. When parking in Downtown Encinitas, we will use the lots along the train tracks. We try to avoid parking in Downtown Encinitas on Wed due to the farmers' market.
- When your survey says check all that apply it doesn't allow you to check more than one--a problem.
- There's too much parking
- Parking in downtown Encinitas is usually pretty impossible. Trying to visit any of the Encinitas
 restaurants that are on the 101 can be quite the challenge, almost making it not worth going to
 those businesses at all. Cardiff is bad as well, unless you're going to a location that has a parking
 lot. Even the VG's parking lot is usually full, though. Trying to park at Pipes or Bestawan is
 usually a big fat miss.
- Please don't ruin character of these places with parking garages/lots. The natural feel of these locations is one of the unique draws of our community.
- Open up the parking lot by Las Olas to the public. Isn't that lot part of the part of the public property anyway? I thought someone from the Coastal Commission told me that.
- If there is any type of special event or if it is a weekend or summer...it can be impossible to find a parking spot
- Parking in downtown Encinitas is a joke. There is never any parking any time of day. Especially come the weekends. Everyone from surrounding cities come to spend time to our beautiful beach community. But there is no parking. And taking away parking to put in meters, or to make it one lane in each direction through Leucadia and Encinitas is absolutely crazy. This is a destination community. You drive to and from it. Taking parking spaces away would also dramatically hurt the businesses in the area. The city needs business revenue from the businesses to pay taxes. Nobody able to park, no more businesses- no more funding for the city.
- We definitely need more parking but I don't really want to see a huge parking garage in the middle of downtown either. I have heard talk of this. Maybe they could build one underneath city hall? Perhaps city planners also could be more aware of not taking any existing parking away when trying to plan to "beautify" the downtown. Business here need to be accessible & customers need to be able to park close by. Keep in mind that a garage at city hall does not help anyone at the north or south end of town. Customers will not walk that far to get something they need.
- I walk to visit these areas more than drive to them.
- People don't have to drive to the beach. They can park a couple blocks away and walk, ride a bike or? We don't need more parking!
- Would be great to have a better parking strategy, and real parking, along the east side of Highway 101 in Leucadia - and along the west side of N. Vulcan Ave. Both areas are dirt and partially city right-of-way and part NCTD rail right-of-way.
- Leucadia I find that I am parking in the railroad corridor more often (only parking available) and crossing Hwy 101 to access restaurants. I feel very unsafe crossing Hwy 101 and don't like it.
- I live near downtown San Diego and work in Encinitas. I'm surprised how much people complain about lack of parking here--if there is not a spot next to the door. There are plenty of spaces on the street, but they require a short walk. This still is acceptable parking in my opinion. If you are within 1-2 blocks of the destination, you don't have a parking problem.
- In all three areas, we use the beaches and retail/restaurants this is our most valuable treasure in Encinitas. Let's not over run it with cars. the thing I love most is that we can still go to the beach and find parking. I've lived in LA where this is virtually impossible. Let's not ruin this for our residents



- Improve San Elijo and Vulcan, do not take any parking away
- Too many cars...too many visitors...too much coastal development
- I live in the Cardiff Walking District and bike or walk to most places. We bike or drive to Encinitas & Leucadia
- Parking should be a primary concern when development is proposed. The first step to keeping
 parking from being an issue is to make sure residential buildings, especially high density ones,
 have enough parking for residents and visitors, to allow for tourist, shopping, and other residential
 parking to not be overrun.
- I walk along the corridor 1-2 x a day do not want to pave this area!
- If I can't find free parking near a restaurant I go somewhere else.
- I like it just the way it is
- I never mind walking a bit... I don't need to park right in front of my destination.
- There aren't enough parking spaces at places of business in Old Encinitas. Most people and residents have to park on the street. Any new business should be required to provide more parking spaces than they do now.

- If you build more parking lots, you will get more cars, more traffic. This does not help your quality of life initiative or our lives. With SAFE bike/ped infrastructure (bike lanes, narrower traffic lanes, lower/calmer vehicle speeds, there is no doubt a
- Again, I am glad walking and bicycling are available options for me.
- NO
- I would much prefer to ride my bike since I live so close to the 101 corridor in Leucadia but there
 really aren't good options to bike with the family in this area. The sharrows on the 101 are fine for
 a group of cyclists but I would never take my 12-year-old on that road.
- Parking is not an issue. Walking one block is not a problem.
- If it was easier to park in Cardiff and downtown Encinitas I would definitely go more often. I would go out to eat more often. It's hard to find parking morning, noon, and night. Every time that is good to eat. So, there is never really a good time to go there. I live and work in Leucadia so I almost always have a spot to park at and then I can walk, or I can just walk from my house.
- I usually walk
- It's not that bad and I always find a spot, even though it may take a minute or two in DT Encinitas
- Increased parking will increase the number of cars. I don't think that is the solution. The
 infrastructure is currently car-centric as it is. Instead of spending money on parking lots, spend
 money on buses, bus drivers and bus stops.
- We could use a trolley system on the weekends like they do in tourist towns.
- Parking is Yesterdays solution. Biking, walking, and public transport are tomorrows solution. It would be better to pedestrianize these areas than add more congestion to them.
- pedestrian rail crossing in Leucadia is severely lacking. There is much more focus on Cardiff and Encinitas but Leucadia is the worst and in greatest need of improved ability to cross tracks on foot/bike.



- I would visit Cardiff and downtown Encinitas, (but especially Cardiff) if there was improved bike access from Leucadia.
- NO PAY PARKING OR METERS! EVER!!!
- Need more services in far north-western Leucadia for residents to walk to. Also, need railroad
 crossing to get safely and legally to businesses and beach from all these neighborhoods.
- This survey says you can pick multiple answers for certain questions but then it will not let you select multiple answers.
- Parking is not the problem. Inviting more cars only exacerbates the crowding. I would rather see
 better access to these areas by alternative transportation, namely by bike. However, since I value
 my life, I avoid riding on the 101 for fear of being hit by a car or have a car door opened on me.
 The current system of chevron lanes is insane and should be retired ASAP. Those lanes should
 be converted into bike only lanes or alternative bike only lanes should be implemented somehow
 somewhere.
- Public parking lots would be nice to have. It would take a load off 101 and the residential areas.
- Because I don't drive so I get dropped off to area. I see it's very busy & parking seems to be difficult to find.
- Make it easier to cross the tracks and walk.
- But I would prefer easier access not just parking for cars! I can walk or bike if conditions were better for bikers and walkers
- being able to bike more easily and safely would make me visit highway 101 more often
- I find that beachside parking to access beaches on the 101 is becoming more and more difficult. Parking while patronizing businesses in Leucadia, Encinitas and Cardiff, I find is the easiest.
- the economy and businesses on Hwy 101 need to have free parking available for business customers and visitors to 101 area in order for businesses (including city generated taxes) to survive.
- Parking isn't an issue currently. It will be if more businesses and residents are introduced.
- So much of commerce is on El Camino Real, I wish you did not exclude it from this survey
- We can walk to Downtown Encinitas as well, so parking there is not always a problem.
- In parts of Leucadia, pave the open dirt between Hwy 101 and the train track. People already park on the uneven dirt. A simple level paving and striping will create plenty of parking.
- Prefer to make these areas more bike and pedestrian friendly. Park away and tram
- I have left an area and gone home if I couldn't find a place to park.
- There are too many people. I never had parking problems only 15 years ago. Stop density and infill!
- Parking already IS easy to find, except at the beach
- If it was easier to park in Encinitas I would probably eat out there much more often than I do. I would definitely go to the beaches in Cardiff more often if the parking situation was better.
- I would prefer that the biking lanes be built off the streets to be able to ride my bike with my children in a safe place and not even have to find parking.
- Make access to Fish 101 easier in Leucadia. I always have to park on the other side of the street and cross over 101. There isn't enough parking on the west curb in Leucadia.
- Why other cities can have 2 story parking garages and we don't is ridiculous
- Increase non-motorized/active transportation opportunities to reduce vehicle parking demand.
- There needs to be a parking structure put somewhere in downtown. Our awesome council
 members that bought Pacific view should make that into a parking structure. What a waste of
 money that was.
- most times i try to ride my bike instead of driving...particularly during summer and holidays when there is a lot of traffic
- I live in Cardiff and prefer to walk. Crossing the tracks and the hi-way are problematic however. When surfing. I use a car and then walk as parking is not readily available in many areas.
- I normally ride my bike to these areas and would love more places to park my bike for visits to the beach, and local shops.



- Since I can easily bicycle to Cardiff and Downtown Encinitas the parking issues are not as much
 of a concern
- With the Coaster and my bike, I am more likely to visit "hard-to-find" parking places than I ever did in a car. For example, I will ride my bike to the beach on July 4th, but I never would do something like that in a car. More parking is not a panacea. But alternative modes need to be user-friendly. A 45-minute bus ride to Village Park is unacceptable, so people will do the 10minute drive and 30 minute drive around for parking instead.
- Parking never enters the decision-making process to visit, dine, spend or recreate in the corridor.
- I'd like to bike and walk. It only takes 15 minutes to get to Cardiff from my house, if it were safe. This question is bias.
- I don't see parking as a big issue
- How can it be easier to find, you head west and you're at the beach???
- Prefer to bike
- Leave it alone
- Parking is not the problem. Bike paths and secure bicycle parking is the solution. Parking should be metered. Funds go to safe access, ROW improvements.

Question 14: Are you willing to walk/bike from your home or parking spot to your destination? (Additional thoughts):

- I am 88 Years old
- Disabled
- Except taking my life in my hands because of cars.
- Depends on how many surfboards / people are in tow
- I don't have a car. I do not want to walk, no sidewalks west of home.
- We do not want a large parking structure or large parking lots in our neighborhoods.
- Not going to carry surfboard, wet suit, towels, waters etc. to beach. Way too inconvenient, not going to talk to restaurant either.
- But trails/paths are not available or very safe
- The walking is beautiful here. I can always get where I want with simple look-left-right commonsense. Where there are no sidewalks, I do not feel unsafe.
- I live in Olivenhain and would love to visit the restaurants along the coast more often. The unpredictability of parking is a major deterrent, though. Have no problem walking a few blocks if I knew of a reliable place to park. It's the searching/uncertainty that scares me off; usually go somewhere along El Camino instead.
- I bike and walk to Hwy 101 often alone, when I have the kids we drive, too far to walk/bike with all our beach gear.
- If there are safe paths for cycling and walking, I'd do it more often. It's not safe from east of I-5 due to the unavailability of connected sidewalks and bike paths.
- Too old to bike or hike
- We currently cannot walk as access and safety are major issues. Meanwhile there is no parking either.
- I usually come for surfing, so I drive to my spot.
- Of course! This would be the preference.
- We regularly walk to destinations. However, I would prefer it be by choice rather than "because its easier than finding parking, or dealing with the resulting traffic."
- This is also my preferred way to get to Beacon's or Grandview as parking in those areas is hugely problematic. Most of the time.
- We need to accommodate handicapped people. Everyone else can walk from their car to the destination.
- I don't have a problem having to walk a short distance, but in Downtown Encinitas or Cardiff it's
 never a short distance. I will park at my job which is basically Leucadia Blvd and walk to Mozy's
 but I'm probably not walking to Pannikin. I wouldn't mind biking to Pannikin from Leucadia Blvd
 but I don't want to always have to drive around with my bike. If I were able to cross the tracks on



- my bike I would bike WAY MORE OFTEN. And walk WAY MORE OFTEN. If I was allowed to cross the tracks probably all of my answers would be different.
- Roads have not been set up for safe bike travel. Although the bike lane on 101 is an improvement, many drivers do not have awareness of how to share the road.
- The Goatheads on the 101 are a HUGE problem for those of us who live off of Vulcan and want to bike. We had to stop biking to the beach and downtown Encinitas because we received so many flat tires.
- I live too far away
- I am a lifetime bike person. I move to the area with the expectation that the Coastal Rail Trail was a done deal. I choose Encinitas based on its bike-ability. Any Infrastructure supporting this activity is greatly appreciated by myself and my family.
- I bike at least once a week from my home in Cardiff to the Del mar post office via the 101 Corridor.
- I don't feel safe biking Encinitas Blvd or Manchester to get to the beach. The bike path over Leucadia Blvd is too steep and narrow. Most bikers go north to La Costa Ave to get to the coast but El Camino can be dangerous.
- I need my surfboard
- I wish the Leucadia area had more crosswalks on the 101 and Vulcan and a safe way to cross the train tracks. It would make walking much easier/safer.
- I need slower traffic speeds on Encinitas Blvd., better bike route through freeway on/off ramp intersections, bigger bike lane under I_5 on Encinitas Blvd., Separation of pedestrians and bike through I-5 lanes in order to be safe to ride a bike to/from downtown.
- Again, people like myself want to walk but there is a severe shortage in safe/legal means to walk along N. Vulcan/Leucadia corridor and to cross the tracks.
- It's level and gorgeous. sometimes the traffic is a bit intimidating, but I manage.
- Railroad is MAJOR impediment.
- It depends what I'm doing. I'm NOT willing to walk multiple blocks if I'm shopping and have to carry packages. I am willing to walk a short distance if I'm going out to eat.
- only concern is crossing the railroad tracks to get to the 101. Vulcan is very unsafe
- Only because walking under the freeway on Enc. Blvd. is DANGEROUS!
- Need railroad crossings in Leucadia for beach and businesses
- I would prefer to Bike or walk!
- I would love to see the walk/bike access at Birmingham over the freeway improved, connecting east Cardiff to west Cardiff better!
- I would love to bike but the vehicle speed and poor bike lanes and lack of separation of crs and bikes plus poor I-5 interchange design makes biking very unsafe.
- I go on walks for exercise. I do not ride a bike. I resent being told to get out of my car and start riding a bike.
- Not a good question I live near the corridor. i walk & drive around Cardiff, but I drive to downtown Encinitas for restaurants.
- I am 70 years of age, biking is not an option and walking is fine, for a few blocks. I park at the library and walk up and down the hills to things.
- I can safely bike to the beach because I am an adult and a good biker. I do not feel it is safe for kids or non-advanced bikers. I would bike more if there were better bike paths.
- Willing to walk but not bike....do not own a bicycle or ride one
- I'm disabled & wish I could walk or ride a bike but I can't. I use a walker & a wheelchair to help get around
- I will always drive my car. It annoys me tremendously that government is trying to get me out of my car. It is NONE of your business and I will continue to drive until I am dead and buried. I walk if I feel like it.
- I would already be biking if the road was safe.



- It is too dangerous to bike on the streets of Leucadia and Encinitas with my son. Riding bikes to Paul Ecke Central is obscenely hazardous at the PCH/Leucadia Blvd intersection. The El Portal undercrossing is vital to improve circulation from PEC to areas west of PCH.
- I mostly walk for short distances around 2 miles, but I would bike for longer distances if the 101 had a safe bike lane instead of taking the car and creating more traffic
- As long as there is a safe route, too many aggressive drivers.
- It needs to be safer. Just try walking it and you'll see unpainted crosswalks, broken signals, potholes, sidewalks that start and end at random, and worse
- Everyone should have the right to be able to drive to their desired destination at any time for any reason. Do not discriminate against people who choose not to bike or walk.

- I am handicapped and unable to walk very far.
- Handicapped--not an option
- I have no problem walking. I do not bike.
- Need Vulcan to be walkable!!!!!
- I am willing to walk if there is a safe place for me to walk. That means NO skateboards or bicycles on the sidewalk!
- I have an artificial leg and walking is limited.
- I honestly have no problem walking from my car to my destination but the reality is if I have to do this every single time I would probably just stop going altogether. I also don't want to bring my bike with me every time I have to go somewhere. I'm already worried about my car getting broken into, I don't need to also worry about my bike getting stolen.
- I am an avid cyclist, but it feels dangerous to ride from the coast to my home.
- If I felt the bike lanes were safe from distracted (texting) drivers I would ride my bike almost every day. I do not feel very safe from cars riding my bike to work.
- I would be willing to bike but the streets are dangerous for bikers.
- Would walk and bike much more if it was safer (curb cuts, sidewalks, bike lanes). A safe route along Vulcan or on the East side of the rail tracks would improve mobility significantly.
- I live on east side of Interstate 5 and would like bicycle friendly road sensors to trip traffic signals for cyclists. This would allow bicycles to proceed with safety.
- I live on a hill and am not a kid. Biking is not an option for me.
- I am nearly 65 and have a bad knee. I do not want to walk or bike to work or the grocery store.

- I pray it won't turn into Del Mar where we'd have meters on all the streets
- Poorly drawn survey asking very limited questions to retrieve specific answers. Shame!
- Again, I've already said I can always find parking except at the beach,.. where we already pay.
- I do NOT think that downtown Encinitas' parking spaces should become metered. I do not think that is the solution at all. That goes for Beacon's parking as well. I think that usually the people that get the parking spots at Beacon's are the ones who make it up there early enough that a spot is available. If we put meters on the parking spaces it will ruin beach days. Having to run up and down those cliffs to feed the meter sounds awful. And where the hell would that money be going anyway?

- It is a positive economic sign that downtown is busy and parking is full the majority of the time.

- A city Trolley would be great on weekends-Cardiff to La Costa
- Please consider having more police presence to regulate the speed. In my neighborhood (101/Phoebe it is often difficult to even turn onto 101. People drive aggressively and too fast. On our street, Phoebe) I have complained to the city for lack of posted speed signage, sidewalks and many cars driving fast and aggressively. This impacts the whole neighborhood, not just our street.
- Don't make it like Newport Beach or La Jolla and even what Del Mar has become.
- I am more concerned about walking/biking safety, either from my home, from my parking spot, or getting around in the Leucadia 101 area.
- Create a local free shuttle to these areas. Think towns like Breckenridge or crested butte where
 people want to go to downtown from more than a mile away but there is NO Parking. The answer
 is not more parking. The possibility of a DUI is a Huge deterrent to going to the coast for lunch or
 dinner. Shuttles also build community as you met people going out for a pleasant evening.

- Swami's not allowing the locals (I'm sure you know the folks I'm referring to) to park there every single day for 12 hours at a time. It would be nice to be able to park, surf or do a walk and then give the spot to the next visitor. Sharing. Parking in the dirt in Cardiff and Leucadia is completely good but having some organization and consistency would be helpful so all the spaces are effectively used. Special Events (street fairs, concerts @moonlight, etc.) it would be helpful to have access to special parking offering or shuttles to run so it's not a complete mess. I usually avoid the area because there's no parking, which defeats the purpose of a special event... you want everyone to enjoy it
- Thank you! The downtown Encinitas could use more capacity especially for special events. A shuttle would be helpful until a garage could be built below the library or elsewhere.
- The idea of local free shuttle like other tourist towns offer might help businesses and locals get around, but not sure our parking problems are that severe in Encinitas to warrant
- I SINCERELY HOPE THAT NO PART OF ENCINITAS EVER BECOMES LIKE DEL MAR WITH THEIR ARROGANT ATTITUDES TO VISITORS AND THEIR GESTAPHO PARKING TACTICS.
- There are very few available lots on or near 101. Leucadia businesses are particularly squeezed. The railroad right-of-way creates a dangerous crossing of 101 situation but it is often the only option. The bike lanes are crazy for individuals or small groups and crazier for those who stay aside as cars squeeze by!
- The best idea I heard from staff member here at the event was the coordination of shared business parking. Parking at schools, closed businesses, etc. should be allowed (assuming they are not today)
- not enough parking!
- The Leucadia coastal corridor parking is barely functional, and it's extremely dark at night. It's
 good to see people supporting the new restaurants but dangerous nighttime conditions may
 destroy the momentum. Employee parking areas should also be explored. I would like to test
 out a single car length 20 minute only parking spot in front of my business, Surfy Surfy Surf Shop
 at 974 N Coast Hwy 101.
- I would love to see public transit options available on a more frequent basis. I'm thinking, it would be great to have electric shuttles/buses circulating along the 101 corridor so I could park once and shuttle to wherever I am going. On a different note, I am more interested in safe bike paths around Encinitas than in parking along the 101 corridor. I'd love to bike more, but don't feel safe using our existing bike paths (I live in New Encinitas near Encinitas Blvd and El Camino Real). I've had close calls and have a good friend who was seriously injured. The solution I support is putting impediments for cars strategically along side streets that would allow pedestrian and bike traffic, but would discourage vehicular traffic. The idea is to leave main arteries, like Encinitas Blvd. or the Coast Highway, for cars. Adjacent side streets would have barriers every few blocks that would allow pedestrians and bikes to pass through transparently, but would block automobile traffic. The barriers could be aesthetically pleasing, like potted plants, so they wouldn't be an eyesore. To provide an example in Old Encinitas, the Coast Highway could remain an artery for vehicles while 2nd Street or 3rd Street could have pots with plants located at F Street and I Street. Cars could still drive on 2nd or 3rd Street, but only people going to a specific address would choose to do so. It would be a much safer route for bikes and pedestrians due to reduced vehicular traffic. I believe Palo Alto and several other cities have such a traffic-shaping plan in effect. Please consider it for Encinitas.
- I would favor a charge for parking to help generate revenues that could go towards improving the bike lanes and safety of bikers along the 101.
- Trench and cover the railroad tracks to add parking and access.
- I don't really have any concerns with parking in this area. We are approaching our 60's and believe in keeping active and try to walk everywhere from Cardiff to Leucadia or bike. Providing safe sidewalks or separated bike trails would be my highest priority.
- need to create parking along highway 101 in Leucadia and get street scape moving, starting at La Costa Ave, not to the south. Area has been neglected long enough



- Parking is almost always available within a reasonable distance except on summer weekends near Moonlight, or during special events.
- I am concerned about too much focus on parking and less focus on building infrastructure,
 TODAY, to get people around in a multi-modal manner and/or using public transportation. Any
 new parking should be underground, where it is not visible (like Whole Foods model). Before new
 parking is created, we must exhaust creating viable and usable bike/ped facilities and enhanced
 public transportation options. Quality of life, climate action planning and fostering a healthy
 community require taking this approach.
- I hope that we will emphasize cycling and public transportation. There is enough parking if we have fewer cars. And that should be our goal. My single greatest concern is bicycling safety. For me, and in my opinion for the area, the most important thing is creating class for, protected bike paths. These bike paths should not be created simply by painting lines on to the road. On major streets, such as Highway 101, Encinitas Boulevard, and Leucadia Boulevard, etc. there should be some type of physical buffer between the bike lane and the roadway. I lived in northern Europe for many years, so I saw how fantastically this can work. But only if safe bike paths are installed. The other issue of concern in Coastal Encinitas is the train tracks, specifically that they prevent people from getting to the beach. The coastal commission claims to be concerned about Coastal access, but the railroad tracks are the biggest impediment. The city of Encinitas should be doing everything it can to resolve that problem. Ideally, of course, the train tracks would be trenched and covered. Of course, I realize this is perhaps financially difficult. If we are going to live with these trains, and the inconvenience, noise, pollution etc. that comes with them, we should at least have convenient Coastal access. That means underpasses in many different places.
- I don't feel that this survey in any way has given me a voice in "What" is going to happen on the 101 Corridor. It just seems to be set up to figure out how to force people to ride bikes, and in what manner we'd be willing to pay for parking. How is that giving the residents a "voice" in the development.
- North 101 has seen a marked uptick in popularity these past few years and that will only continue. It's time to begin the streetscape project for that area.
- Building parking lots/garages will ruin the character of Encinitas. Parking lots/garages are ugly,
 they attract homeless people, they're disruptive to the neighborhood. Additional parking will bring
 more noise late at night and higher carbon emissions. If you build parking lots, you'll get more
 cars. . .We need public transportation and more bike paths. Uber and Lyft have reduced the need
 for more parking.
- It seems like this survey is geared towards seniors. i hope we are not creating a mobility plan just around them.
- This city may be lacking some parking but the idea of complete streets would be a disaster!!!!!
- If there were access across the railroad tracks, you would not need to drive as far and you could walk or bike. Additionally, you have many bus stops that are very difficult or illegal to get to along the corridor. That certainly makes public transportation more difficult.
- The natural areas along the railway between Santa Fe and Manchester are what makes this community unique. Please don't pave or alter these areas under the guise of "improvements". This wild and scenic expanse gives our community its character. Dirt footpaths, wildflowers blooming in springtime, natural vegetation. What other coastal southern California city can claim the same? I fully support safe bike paths throughout our community, but there is no need for those paths to significantly infringe upon this area. All it takes is a small sliver of dirt adjoining the roadway to create a bike path. Anything beyond that is an overly-ambitious and wholly unnecessary act that will destroy one of southern California's last remaining untouched corridors. I wouldn't want that as my legacy. Would you?
- Parking on West side of North Vulcan, along the rail tracks, would be helpful. It is close to
 moonlight & downtown. Providing a north south walkway through the vacant lot on NW corner of
 Vulcan & Encinitas Blvd. would make walking safer & more enjoyable.
- I feel that the 101 Corridor is very dangerous for bikers when going south by the campgrounds in Cardiff, especially the section from Chesterfield through Restaurant Row to Seaside parking lot before entering into Solana Beach as some areas have no bike lane and cars are parked lining



- the street where they are opening doors, not looking while leaving, etc. You also have to worry about cars driving past you.
- I don't think parking is the big issue with the coastal corridor. The problem that needs to be addressed is legal access to crossing the train tracks. If we could legally cross the tracks, more local residents would walk to the beach or shopping and leave the parking spaces for the tourists.
- We need better access to cross the railroad tracks! We are cut off from lots of good businesses because it is illegal and difficult to cross from the residential communities to the business communities in Leucadia. We need at grade crossings or let us cross without threat of ticket8ng!
- Enforcement of existing hourly parking areas.
- I think that moonlight beach should be paid parking \$10 at least. I think prioritizing active transportation would alleviate a lot of smaller parking issues.
- I don't think that more parking and more regulated parking are the solution, it will just encourage more and more cars. I think that more public transport options would help to bring down congestion. Public transport that is frequent and reliable and cheap. If it is free for children and seniors that would be great.
- Please provide a safe way to cross the train tracks in Leucadia between La Costa Ave and Leucadia Blvd. This is a growing residential area with currently no good walkways or paths alongside or over the tracks. It is a liability issue for NCTA and the City of Encinitas. Further, as mentioned previously the fact that there are numerous bus stops alongside the tracks and the 101 but no pedestrian cross walks is a huge risk exposure for the City. It is extremely unreasonable and negligent to expect the elderly and children to walk a total of 3 miles to get to the other side of the tracks or the 101 to access businesses, homes or bus stops. This needs to be addressed as soon as possible.
- We need to create new parking lots for the amount of development that has occurred. We don't
 need to charge to park. This city has enough money. We need to provide a trolley service on the
 weekends that goes up and down the 101 corridor. We need to make this town a positive
 experience for the tourist and create an atmosphere of fun since this is a beach town. We need
 to provide services for the tourist and copy other beach towns and encourage tourism.
- Would be nice to improve the parking along the coastal railway on the 101 side to allow for more parking and have signage.
- We need more crosswalks and a safe way to cross the train tracks in Leucadia.
- yes, don't be tempted to just add more parking, all you will do is increase the amount of traffic and need more parking - but by doing this you will not only fail to solve any perceived parking issue, you will also begin to destroy the character of the area. I have a good idea - leave it alone. It costs much less and ultimately this problem will solve if current parking is left as it is.
- Leucadia is constantly forgotten about and is in the greatest need. New restaurants and businesses along the 101 are opening daily and we have very limited legal access to these locations that are steps away from our homes. It is a shame to have to drive 1-2 blocks because the city has not made it safe/legal to walk. Orange County has many at grade rail crossings and there are not more deaths or injuries as a result. There is no real reason we cannot make crossing the tracks easier, safer and legal -- the only impediment is bureaucracy. The people want this to get done -- sooner rather than later. Finally, I believe it has been determined by past suits that the dust/debris from the trains is a public safety hazard -- Leucadia gets crushed by the dust from the trains as we have nothing along the rail corridor except dirt and weeds which occasional work crews pull out. Simple ground cover and improved parking/walking areas would significantly reduce this.
- Bike parking needs to be available in more areas. Note, I am in my 70's and am not a spandex rider.
- So much is needed for Vulcan
- As mentioned earlier in the survey, I live on Jasper Street in Leucadia. Since the increase in bars/restaurants along the 101 Corridor in my neighborhood, we've been plagued with an increase in car traffic into our neighborhood. They are looking for parking to get to those bars/restaurants. As there is none, they come into our neighborhood looking for space. They



drive too fast, they hit our parked cars, they cut through private streets in spite of signage stating not to, they pull into our driveways to turn around. It has become a HUGE issue on Jasper Street. To add insult to injury, they are rude, they damage our property, they speed and it has become incredibly bad Friday - Sundays, and during the summers now. Ask anyone living in the neighborhood and you will hear how all of this has degraded our quality of living. I've been called foul names for telling people to slow down, or telling them they are trespassing on private property. We are attacked verbally now on a regular basis. We had one driver while trying to find parking, run over our children's' bikes/scooter on our private street, as he was frustrated about not finding parking, and felt he was entitled to cut through our community. Again, we have large signs at the entrance telling people it's private property-not a turnaround-or through street to the public. I no longer enjoy living here, and we feel that the City has no regard to the residents that are affected by this. We don't understand why the businesses are allowed to open, in our neighborhood, when the is no parking available to them. I've lived in my home since 1987 and the changes to our community have had some positive impact, but an even larger negative impact. The growth doesn't fit the infrastructure. I'm preparing to sell my home and leave the area, and it's a shame because in a sense, I feel like I'm being driven out, by the City.

- no pay parking please!!! It's my home town. It's Encinitas!
- I have stated my thoughts throughout. Please consider them. Insufficient parking impacts quality of life more than traffic! Please don't turn Encinitas into the outlet stores in Carlsbad. What a nightmare. You have to spend half a day there just to get your effort's worth for finding a parking space. Perhaps the new arts center at Pacific View can also house additional public parking for downtown, and leave open land to build a parking structure/underground parking structure decades down the road. Find land now for parking structures in the future; it will become necessary. Consider one-way streets and back-in parking: space-saving and bicycle-friendly.
- Again, safer access by bike and foot is my main desire. We live in the most bike/pedestrianfriendly area with regards to the weather but also the least accessible due to lack of infrastructure.
- Encinitas has created such a great place for so many San Diegans that it has become a major
 local destination. So, locals' quality of life has decreased wile locals pay for a lot of infrastructure
 (Moonlight Beach remodel, life guard tower remodel), stairs down bluffs. So the grants aren't
 matched by funds from local cities, just Encinitas, yet residents from other cities love to use our
 beaches. So, locals will need a discount and out of towners should pay a premium to help pay for
 their use of local improvements.
- · Build a parking garage
- Maybe larger parking lots could be located just behind the main streets, one block away, so we can walk around the corner and be on 101 to shop/dine. Free lots please.
- On street parking of vehicles is dangerous for cyclists! Drivers don't think to look for cyclists before opening their door (even I don't and I should know better). When backing out of a head-in, angled spot, drivers don't see cyclists unless the cyclist is in the middle of the lane. As a cyclist, it's difficult to stay out of the way of moving traffic, out of the way of opening doors and be visible enough. My point is: please don't add on-street parking.
- Buffered bike lanes are the key!?!? Think about going through quail gardens or keeping off the big roads. It is OK to go a little out of the way to reduce hill size or traffic.
- As more and more homes and condos are constructed in the area, parking will become more
 difficult. Traffic on any given day is becoming more and more congested. Several east-west
 streets end at Vulcan, so there is no easy way to access Hwy 101 from these streets. Also,
 consider that the mentioned beach city coastal corridors are strong tourist attractions that draw
 many more visitors in the spring, summer and autumn months that the winter.
- I don't want our city overrun with bicycles. I don't ride a bicycle nor do I own one...every accident I've had has been on a bike and I just won't ride anymore. Walking, crossing coast Hwy at the campground, heading to Seaside Market, a bicycle rider almost rammed into me, speeding through the red light there... Also, please plan to have 'Park and Ride' areas. Already, there is no parking at Glen Park on the weekends. Bike riders drive their bikes to the park, park their cars, get on their bikes, and ride away for the day. How can you encourage riders to park at the new



Manchester park and ride being built soon, as it is so far from the coast? How can you get them to park anywhere else in Cardiff as all the parking is already taken up? Does the plan have places for bike riders to park near the coast or the rail trail? Please don't let us be overrun with riders....be extra concerned with car, transit, and pedestrian users.... I'm a senior citizen who one day will be without a car. What services do you have planned for us? For those who are disabled and can't walk, ride a bike, or find a nearby place to park? I still think we should underground the train through Cardiff and put a roof over the top with a gathering area for residents. Access crossings should be placed every 2 blocks but especially from the campground to the Cardiff downtown. Maybe we could do Kickstarter or crowdsource to raise funds. The worst part about living in Cardiff is being cut off from the beach by the train.... I just can't understand why cities and the coastal commission have not demanded that the train supply these crossings..... especially since so many have lost their lives crossing the tracks. I hate having to drive to Solana Beach to use the train..... remember when the train stopped in Cardiff? At least we didn't have to just put up with all the trips just passing through...... Thanks for listening. We need a vision that moves people, all people, not just bike riders and walkers..... Thanks for listening.....

- Try different ideas: A Shuttle, Valet parking, car pool parking areas, the Coaster has routes from
 point A & B that gets you directly into the Beaches, downtown Encinitas and all the areas named
 above. Use "Uber & Lyft & Lift" and provide designated drop-off AREAS at/near these
 establishments for easy access in & out for these transportation Companies. Make sure there's
 plenty of room for wheelchair/Walker access with Ramps in more than just in front of
 establishments.
- The north 101 parking corridor
- Need more beach parking! Need more underground crossings of the RR tracks. Need more
 parking in downtown Encinitas, Cardiff and Leucadia. Will go to another location for shopping,
 lunch, dinner, etc. if can't find parking. Need to preserve natural trail along RR tracks in Cardiff
 for runners, walkers, dogs, bikers.
- Backing out of angled parking in downtown Encinitas is extremely dangerous and difficult most of
 the time. The overabundance of pubs and restaurants from Athena St to Basil St in Leucadia has
 severely congested our neighborhood with the increase in patrons and employees' cars. People
 parking along the tracks and illegally crossing PCH is going to result in a fatality soon.
- Parking along the 101 on the west side of the road south bound is somehow dangerous for bicyclists getting hit by car doors opening and is also dangerous for the people that park on those spots because the traffic coming south is very close to cars parked. In Leucadia, there is not light poles to light up the 101. That would highly decrease the danger of car vs pedestrian hits, prevent robbery and in general safety.
- I would like to see parking and cyclists separated. We need more protected bike routes.
- There is so much traffic in Leucadia and Encinitas that I don't even want to go there at peak hours. Encourage people to stop driving alone everywhere, make public transportation more efficient for people coming into the corridor and promote pedestrian and bike movement instead of more spaces to park for cars. Evening parking on east side and then walking over to west side to eat and shop and walk. No more parking west of 101. Get those over and underpasses done so we can cross the tracks safely! Please don't leave Leucadia until last. We need that grand view walkover done ASAP! So dangerous and impractical to let it go
- all too often people parking along the 101 create extreme hazards for bikers and pedestrians. It
 doesn't make any sense to have a bike lane in between parking spots and cars driving along the
 101. The southbound bike lane along 101 should be directly next to the sidewalk with a physical
 barrier, like a curb, between the bike lane and the parking lane. A class 4 bikes only cycle track
 needs to be used on the 101. It's the safest most common sense solution to safer streets.
- There needs to be more parking enforcement and management along the 101 at George's Beach. Too many motorhomes camping out all day taking up multiple spaces. Lack of signage, hours and how to park (park parallel or angle).



- It's almost impossible to go from East to West. Driving is tough, cycling or walking is nearly impossible! It's almost as if Old Encinitas has done all it could to block access from the majority of the population.
- No paid parking PLEASE!!!!!
- provide more free street parking where available. move bike lanes to second or third street so shoppers can easily use coast hwy. 101 and visit businesses. (bicyclist don't shop, and it is a business district) more free handicap parking spaces. no meters. turn the hill and parking lot at the Encinitas City offices into a multi-level free parking structure, to be used for shoppers, commuters, residents, visitors and staff/visitors to the Enc. City offices.
- I might offend you with my comments, but use your imagination.
- If there was easier bike access to get around I would not have to drive to places and parking would be less of an issue. Also, the traffic coming from Leucadia Blvd. onto the 101 needs to be re worked. It currently takes way too long to go through that intersection
- Yes, if 101 is built out, more businesses and residence, parking and traffic will become less tolerable.
- Traffic is fast down 101 and the cyclists do not always seem to follow the rules of the road. I also
 need to consider if walking or biking will be safe for my family and how much gear I need to bring
 with me, if we are going to the beach. For the most part, I do not find parking to be an issue. I
 enjoy going to these locations.
- Please do not start charging for beach parking. That will only hurt the local surfers and paddle boarders. Having a right to use the beach for free is what makes Encinitas so amazing.
- Find a way to separate the vehicles and bicycles. a bike buffer zone would be good. not just a line painted on asphalt. a LANE that protects the cyclist. this will keep the cyclist safer and prevent them from riding into, or in front of vehicles. I am sure some of that behavior incites road rage. keep the two modes of transportation SEPARATE.
- Summers are a challenge but off season is OK......a better, wider walking and riding corridor would make for safer and more enjoyable walks and travel between Leucadia and Cardiff.....let's make this happen!
- Too much of our valuable coastal property is already devoted to parking. People seem to be reluctant to walk a few blocks, even if there are available spaces.
- Put paved diagonal parking in Leucadia on both sides of RR tracks and legal crossovers and pedestrian walkways to access businesses along 101
- Vehicular traffic moves too fast on the 101, if you could slow down traffic on Vulcan and the 101, find a better use of the train corridor, perhaps parking issues would be solved. It would also be awesome to have more access to cross the train tracks, then the train corridor could be used on both sides for parking. The biggest problem is the traffic speed and general lack of safety for pedestrians and bikers in the area. Building an extended biking/walking trail linking Leucadia and Cardiff-by-the-Sea or limiting the driving on the 101 to 1-2 lanes and a designated biking only lane would be great! The 101/Vulcan are way too busy, it is used as an alternative route for the 5 Highway during morning and afternoon rush hour causing it to be a very unsafe road, not a residential/retail street.
- I have paid for a State Beach parking pass, but this is not accepted at any of the beaches mentioned above. This means I will drive to Del Mar or Carlsbad in order to walk the beach (and have a snack afterwards.)
- Yes, we have bike lanes to encourage cycling and help with safety, but vehicles often park in the bike lane forcing cyclists and pedestrians into the roadway. The vehicles never seem to get ticketed. Please: more enforcement, more signs, and wider bike lanes with buffer zones between them and the parked cars for when they swing open their doors.
- Please, please do NOT reconsider putting the rail trail on the east side of the tracks in Cardiff.
 101 is the best place for it. Thank you for your work!
- I think a lot more people would walk to each of these three downtown locations if there was a safe and legal way to cross the tracks. I think a huge parking issue is that residents are driving to these locations from not very far distances. Those of us that live off of Vulcan are so close, yet so



far. Not being able to cross the tracks turns a 5-minute walk into a nearly 20 or 30-minute walk, but still a 5-minute drive. So, which option do you think people are picking? People are opting to drive to places that are a stone's throw away, and taking up parking spaces that people from out of town could be using. The Swami's crossing is excellent, but mostly if you're going to Swami's. It doesn't really help the large community that lives behind the Lumberyard (another place it is difficult to find parking in..) or all those residents in Cardiff. I think the same goes for Leucadia. As I live and work in Leucadia, I know plenty of residents (sadly myself included) that drive to work, or to get a cup of coffee, or to a hair appointment when they could easily walk. I really think that if crossways were improved, we would see a decrease in vehicles on the road, and that would also open up parking spaces.

- Parking is not usually a challenge. Beach trips on weekends can be a small challenge, but I don't
 mind walking a few blocks, and can usually park within a few blocks of the beach
- The rail trail should be on San Elijo Avenue. It is redundant to have it on Coast Highway.
- I think parking at Moonlight is sufficient. I do feel sorry for the neighboring residents during the summer but it's okay to walk. Downtown Encinitas improved parking adjacent to the Coaster station and I don't find any problems there. I really don't see an issue with downtown Encinitas. Leucadia is the most challenging with all the restaurant activity so I always park on the east side along the rail corridor but crossing 101 can be challenging for many and City engineering staff should certainly address this safety issue. Our City is on notice of this dangerous condition and is an easy target for liability exposure. I'm not concern with Cardiff either. Let's be practical, we're a beach city and sometimes you have to eliminate the car during the summer and get on your bike or walk further. Concentrate on bicycle and pedestrian facilities which may include dedicated bike lanes, better signage, landscape maintenance regarding overgrown vegetation, improved intersection control and law enforcement.
- Parking and exiting safely pertains to parking on 101 between La Costa and Encinitas Blvd.
- I would like to see 2 blocks of the downtown Encinitas area closed to cars so that it becomes
 more walkable and pedestrian friendly. If underground, or more parking was available, this area
 could become a North County hub for all of us to enjoy, instead of dodging cars, hearing loud
 motorcycles, and fighting for parking.
- We are a community of older people who don't bike. My mother used the "dial a ride" service that was around and it took her 1.5 hours to get approx. 2 miles. Don't take our parking spaces away.
- Would like to ride a bike more often but do not feel very safe doing so too much traffic, too fast, and people don't seem to understand that bikes have a right to be on the road.
- Don't not take away parking, do not implement roundabouts in Leucadia. Do not do anything to restrict traffic, such as reducing our north and south bound lanes to one lane. Get bikers off the highway, put them on the side of road, or make trail for them along the rail road tracks and put them on 3rd street to get them out of downtown. I can't believe there hasn't been more accidents or deaths of bike riders getting hit by cars backing out in downtown. There are more cars than bikers, always has been always will be. Encinitas is not a walking a biking city. You drive to, you drive through it. People come from all over to get to this city. Keep it that way. Get the people in our city council currently out of their positions and see how much better this city will run. This people do not know anything about running a business or thinking about good solid future development of this great and beautiful city.
- Very difficult to find parking for restaurants in Leucadia.
- I personally don't have an issue with the current parking situation in 101 Corridor.
- I prefer to walk and bike when possible. I find it unsafe to bike on the Coast highway in Leucadia and Encinitas. I end up biking on the sidewalk in Leucadia....which i know is not good.... but I worry I will be hit while sharing the road with cars. There is just not enough space. In down town Encinitas I try to use the side streets instead of the Coast highway.
- I will not park on Hwy 101 now that you have put in sharrows. I won't park in Solana Beach on the Hwy either. It is too dangerous for the bikers and for the autos. Please move these sharrow lanes to 2nd or 3rd where it is safer for all.



- If there was better crossing for hi-way 101 and the railroad tracks it would greatly improve things.
 More people would walk and cars could be parked at reasonable distances away and walk the last bit.
- I think diagonal parking with free up a lot more space than parallel parking. Also, it is hard to know where to park on the dirt each side of the train tracks. At any rate, as a biker, the cars totally dismiss the 3'rule and often nearly sideswipe bikers. Even when in the biking lanes cars don't like to go around. A much safer biking and walking situation would be great.IN BELGIUM BIKERS GET A TAX REBATE FOR USING BIKES TO WORK. WHY CAN'T WE DO SOMETHING LIKE THIS FOR A YEAR TO CREATE MOMENTUM AND GET PEOPLE IN THE HABIT.
- Better signage, maybe more safe "crosswalks" for people who park in the dirt areas on the east side of Highway 101 - but need to cross the Highway to reach businesses on the West side of the Highway. Lots of ample parking area, but needs better signage, etc. and more safe places to cross intersection.
- Parking currently in Leucadia is a hot mess. The other areas are just fine.
- Additional controlled pedestrian crossings on Hwy101 would be very helpful at the North end of
 the San Elijo State Park and Leucadia area both north and south of Leucadia Blvd. Older adults
 and families with small children cannot cross HWY quickly and it is very stressful to cross without
 designated crosswalks. It is too far to walk to the intersections in these areas and parking is very
 limited on the west side. In addition, I am not sure the sharrow lanes are making bicycling any
 safer. As a cyclist and walker, I would love dedicated paths in the rail corridor from La Costa Blvd
 to San Elijo.
- People will manage to find parking if they want to visit these locations. I like Encinitas for the beaches and new establishments as well as the old establishments (like Juanitas...and I still miss my Sub Palace grinder). I grew up here, went to school here, work here, play here and love it here. I think we have a great community and "protecting" it is an elitist attitude. What we need is real leadership around the inevitable growth and evolution of the city while allowing as much public enjoyment as possible. Public enjoyment doesn't mean excluding the public by limiting parking or development. It means responsibly finding creative solutions to the issues we face in an expeditious manner. If parking is needed, go up, or down. Open parking lots are the biggest waste of land use in the history of society. For any type of development, going up or down to satisfy parking on a smaller footprint should be encouraged and should not count toward the "story" count. Height restrictions are causing all sorts of weird sprawl that people claim to be trying to avoid. In reality, the city is being strong-armed by those who are already here and it is not conducive to workforce housing or even remotely attainable housing for our children. I want my kids to be able to live here and raise a family. It is becoming a near impossibility at today's prices. Slow growth measures and current zoning laws are driving the cost of housing out of reach. Don't let the parking issue become another reason to restrict the housing supply here. Permit more, smaller, attainable housing and encourage folks to walk or ride a bike by putting that housing near the day to day uses. Jobs and shopping. There is nothing wrong with a 600 SF one bedroom and one dedicated carpark if it is located properly. I am certain my views are in the minority but I think everyone should have a chance to grow up here...it's a great place.
- I understand the City wants the community to have less cars and more people walking or riding a
 bicycle. One of the things that might be helpful is to have a "trolley" going up and down Coast
 Hwy. from the Kook to Leucadia, stopping at certain locations along the way. I mentioned this
 many years ago to a couple of City Council people who told me "this is not San Francisco". I do
 realize that, but a free "trolley of some kind" up and down 101 would take away some of the car
 traffic.
- There's always space for bikes!
- Parking is not the issue. I see adding more cars in the future with all the potential development
 that might come to the 101 if Measure T passes as the biggest single threat to Encinitas.
 Adding some parking is fine to avoid overflow into neighborhoods but adding tons of parking to
 encourage lots of cars coming into the 101 area would kill what makes Encinitas special. if you
 want to bring more people in maybe you should consider trolleys or shuttles from a park and ride



area. Let's not burden the downtown area with traffic. Already I feel like when I'm eating at a restaurant I'm just looking out at a sea of cars. To me, we should be encouraging walking a biking and not cars in the downtown area. It would be great to have walking streets with outdoor cafes etc. - but who wants to sit in a sidewalk cafe breathing in car fumes and looking at rows and rows of cars.

- Please do not start changing the livelihood of downtown Encinitas or Cardiff. I am a business
 owner and need to take care of my family. Making any drastic changes to our roadways will
 affect my business for the worse. Thanks for listening and keep in mind the wellbeing of local
 families that make their living here.
- Reverse angle parking is safer for bike riders and easier for drivers than tradition front-in angle parking.
- Improve San Elijo/Vulcan with a sidewalk and crossing to downtown Encinitas
- This relates to the rezoning plan...The city has no ability to manage our present situation...adding hundreds of units in the over taxed coastal area does not make sense. I also believe that the city council has an obligation to protect long limit local businesses from outside greed.ie: El Callejon, Kealani's and Manhattan Giant.
- Setting up walkway and bike friendly should not impact on regular commuting traffic in our town. When the freeway stops the roads clog as it is, reduce lanes and it gets worse. Look at the mess in Del Mar and Solana Beach during rush hour now. We should not want that. The longer a commuting car stays on the road the more air pollution stays in our town. Keep the commuters moving. Provide adequate walk and bike paths, as close to the ocean as possible for recreation and exercise. Zone properly for needed parking on business lots for commerce. Zone properly for needed parking in new residential development. One and a half spaces for a two-bedroom unit in not adequate.
- I think the rail trail should be positioned EAST of Highway 101.
- In a perfect world, a buffered bike lane would extend from Solana Beach to Ponto Beach while maintaining open access from neighborhoods to the beach. I advocate for safer bicycle transit.
- Parking should be easy, but not at the expense of the people living and working there. We will
 always need more parking, but by providing it, we do not promote walking, biking, or using other
 transit which can reduce the huge impact that more cars on the road has on our city and the
 environment. Also, more pressure on developers to provide adequate parking for their projects is
 a must. A great example is the lot under whole foods. Without that lot, the parking on Main street
 would be incredibly worse on that and neighboring blocks.
- NC
- Leucadia parking can be especially difficult, and safety is a priority when walking with kids. I'm not willing to park by the railroad tracks and risking run across the 101 with my family. Sometimes we have been unable to find suitable parking as a result and have chosen to dine/shop elsewhere.
- Give an incentive to those who run their errands on bikes. Provide free shuttles for residents that live up the hills that use their bikes on the 101 corridors.
- Don't remove or reduce parking on San Elijo Avenue
- Parking on dirt (especially near the tracks) should be discouraged. It is dusty and, in occasional rainstorms, causes dirt to be tracked into a car and home. We are a visitor-serving community and it is important that locals and guests be able to park safely and securely. We probably need to provide more municipal parking lots and build parking structures so that employees of our businesses do not have to take on-street parking spots. And parking should be free to the user. Our main street businesses would suffer if we had parking meters, shoppers would go to El Camino Real or to Solana Beach and Carlsbad. Limiting the duration of parking tends to intimidate people and would reduce enjoyment of our beaches, libraries, businesses, restaurants, and other facilities. Parking meters are just as bad and the cost of installing them, collecting the quarters, and fixing broken or damaged meters renders them useless.
- Don't spend another dime on studies, etc. having to do with this subject.



- Downtown Encinitas has very limited parking. Almost always difficult to find a space within blocks.
 Some safety concerns with backing out on 101 into traffic too. Beacon's has hardly any parking, and Swami's is only a bit better. Moonlight is often ok for parking except in the summer.
- Traffic on the 101 is becoming gridlocked in certain areas, and increasing yearly. Especially noticeable is southbound 101 through Leucadia approaching Leucadia Blvd. Traffic is often backed up 4-5 blocks. the coming corridor changes to one lane will undoubtedly cause major backups. I am not sure this will be good for business. My guess is that it will drive away many who now come there for the businesses. I would like to see the city paint and set out sawhorse types of barricades per the proposed plan (cheap portable) and test the proposed design for one summer before spending the money to irretrievably change the traffic flow. Such an experiment will show the actual results of the new plan, without the costs and permanency of the actual plan. Once it is built, the city (if it does cause issues) will be stuck trying to rationalize and defend what was done. Why get into that position? If it actually does work well, then we can all breathe a sigh of relief.
- Yes. When I come home from work heading north on Hwy 101, I turn right on Chesterfield to go home. Sometimes the line of cars is all the way back to the Kraken. Then there is the train to contend with. And people turning right on Chesterfield pull all the way onto the right and block the bike lane. It is a horrible situation.
- Parking requirements may be reduced if safe, alternative transportation infrastructure is available.
 For example, bike and walking lanes separated from vehicle traffic. This not only may reduce parking infrastructure requirements, but improved, local, non-auto circulation may result in economic benefits to each of the 'downtowns' (Cardiff, Encinitas, Leucadia) as it will be easier for people to travel from one area to another without worrying about parking availability.
- Yes! The angle parking in Downtown Encinitas. Backing out of those places scares me so much, that I will drive around in circles to find other spaces if I need to park there. Please change it to reverse angle parking on Coast Highway!
- There should be designated spots for food trucks. Parking should be restricted around Glen Park so traffic is not affected. Now it is NOT SAFE. Maybe some of the park could be converted to a parking lot.
- Parking is ugly, no need for more parking in Encinitas!


Intercept Survey:

Intercept surveys were conducted at each of the three Coastal Corridor communities. Surveys were taken during typical mid-week days (Wednesday and Thursday), as well as during a typical weekend (Saturday) between October 29 and November 3, 2016. The intercept survey consisted of ten questions, which gathered information such as residence, purpose for visiting the Coastal Corridor, opinions on ease and availability of parking, and priorities surrounding future possible solutions to parking congestion. The



following results are presented in a comprehensive, as well as location-specific format, to illustrate holistic trends, in addition to details that may vary between Coastal Corridor communities.


Question 1: Where do you live?



In general, respondents were found to reside in locations outside of the Encinitas City Limits. Of the 245 individuals that answered this question, 104 were visiting the Coastal Corridor from another City.




A total of 65 respondents were polled in Downtown Encinitas. Similar to comprehensive trends, the largest number of those surveyed were visiting from elsewhere (23), followed by Old Encinitas (13), and Leucadia (10).



A total of 65 respondents were polled in Leucadia. Contrary to holistic trends, the most common place of residence among those surveyed was Leucadia (28). Those that were visiting from




other cities formed a close second (25).



One hundred-twenty of the 245 respondents were intercepted in Cardiff. A significant number of individuals were found to be visiting from another city (56), with the next most common place of residence being Old Encinitas (26).

Question 2: What is your purpose for visiting today?




A total of 251 individuals chose to answer this question. The most common purpose stated was Recreation, encompassing 124 responses. Visiting a Business was the next common purpose, with 59 respondents.

In Downtown Encinitas, a total of 68 responses were gathered. Visiting a Business was the most popular purpose for visiting, with



28 respondents, followed by Recreation, with 18 respondents.



In Leucadia, 66 responses were received for this question.
Visiting a Business was the most popular purpose for visiting, with 29 respondents, followed by Returning/Leaving Home, with 12 total respondents.




A total of 125 respondents were located in Cardiff. Of these, 100 individuals stated Recreation as their purpose for visiting,




forming a significant majority. Work-related purposes were the next most popular, 9 responses.

Question 3: Would you come to the area more for leisure activities if parking was easier to find?














Question 4a: How many people are in your party?












A total of 243 individuals chose to answer this question. In each location, parties of 1 or 2 persons were most commonly found. One-person parties consisted of 131 total respondents, including 27, 30, and 74 respondents in Downtown Encinitas, Leucadia, and Cardiff, respectively. A total of 81 respondents reported their party contained two people, including 16, 30, and 35 in Downtown Encinitas, Leucadia, and Cardiff, respectively.




Question 4b: How many cars did you take?










A total of 243 individuals chose to answer this question. Single-car trips were most common overall, with 152 respondents, followed by 0-car trips, with 68 responses. In Downtown Encinitas, 1 and 2-car trips were most common, with 44 and 7 respondents, respectively. In Cardiff, 0 and 1-car trips were most common, with 32 and 84 respondents, respectively. In Leucadia, 0-car trips were more common than 1-car trips, with 31 and 44 respondents, respectively.



Question 5: On a scale of 1-5, please rank how close or far you parked from your destination (1-acceptable, 5-unacceptable)?



A total of 173 individuals responded to this question. The majority of individuals found their parking distance to be neutral or positive, (163 people), whereas 12 people had a negative perception of their parking distance relative to their destination.



In Downtown Encinitas, a total of 52 individuals responded to this question. The majority of individuals found their parking distance to be neutral or positive, (51 people), whereas 1 person had a negative perception of their parking distance relative to their destination.




In Leucadia, a total of 33 individuals responded to this question. The majority of individuals found their parking distance to be neutral or positive, (31 people), whereas 2 people had a negative perception of their parking distance relative to their destination.





Question 6: How would you describe the availability of parking within the area?




A total of 251 responses were received for this question. In all, 140 responses indicated that a parking space was always or usually available, whereas 111 responses indicated that it is sometimes or usually hard to find a space.






In Downtown Encinitas, a total of 66 responses were received. A total of 41 responses indicated that a parking space was always or usually available, whereas 25 indicated that it is sometimes or usually hard to find a space.





Question 7: How many times have you parked within Coast Highway 101, Downtown area, or on San Elijo Avenue today?











A total of 251 responses were received. The most commonly received answer was 1 time, with 140 total responses received. This includes 45, 31, and 64 individuals who responded they parked along the corridor 1 time in Downtown Encinitas, Leucadia, and Cardiff, respectively.



Question 8: Would you be willing to pay a user fee for parking if a spot would be readily available?











A total of 245 responses were received. Most individuals responded that they would not be willing to pay a user fee for parking, even if it were to make parking more readily available, with 196 "No" responses. This includes 50, 50, and 96 "No" responses in Downtown Encinitas, Leucadia, and Cardiff, respectively.




Question 9: Rather than using a car, would you walk, bike, or use transit to this destination?











A total of 249 responses to this question were received, and results were found to vary from location to location. In all locations combined, 126 individuals indicated that they would be willing to walk, bike, or use transit. A further 96 individuals indicated that they would not be willing to do so, and 27 respondents indicated that they used active transportation for the trip that brought them to the Coastal Corridor that day. Those interviewed in Downtown Encinitas that did not use active transportation for that day's trip showed a stronger preference to not walk, bike, or use transit, with 31 replies indicating "No" compared to 21 indicating "Yes" and 14 indicating they used active transportation for that day's trip. In Leucadia and Cardiff, more individuals indicated that they would be willing to walk, bike, or use transit, with 45 and 60 affirmative replies in Leucadia and Cardiff, respectively, compared to 12 and 53 "No" replies, and 8 and 5 replies from individuals already using active travel in the two communities.




Question 10: What would be the most important thing to get people to use active transportation, like biking and walking?



A total of 182 responses were received. In general, many of those surveyed believe that enhancing the safety of facilities, such as widening sidewalks or increasing horizontal buffer to bike lanes is the most effective way to encourage use of active transportation, with 79 responses.







In Downtown Encinitas, Leucadia, and Cardiff, where a total of 45, 45, and 92 responses were received, respectively, a similar trend established the preference of safer facilities as a means of encourtaging new users. Each community was divergent in the responses received for the second most important tool for bolstering active travel. In Downtown Encinitas, the establishment of bike parking and support facilities was indicated to be the second most popular method, with 6 responses. Intersection control features were the second most popular method of encouraging new active travelers in Leucadia, with 7 responses. In Cardiff, other methods were thought to likely be more effective than the remaining five choices, with 19 respondents indicating "Other".
