## 4. PUBLIC COMMENT (15 MINUTES)

Attended the CMLS Open house on 12-20-2017 and was appalled to see that trails and sidewalks were recommended for his neighborhood, when he and his neighbors petitioned against a similar plan for two years in 2000. 183 residents signed a petition which led City Council to remove the trails from the "City of Encinitas Recreational Trails Master Plan" in 2002. Relevant news articles were shared, and a request was made to remove all trails and sidewalks from the ATP in this neighborhood. (Joe Tunner)

The City is barreling through and Cardiff is about to lose its beach access, because the Verdi undercrossing will not be done for years. Also expressed that there should not be extra parking at the Verdi undercrossing because it will only be used by tourists. (Julie Thunder)

Lives across from Verdi undercrossing and expressed concern about not having beach access until construction is done. Verdi should be first priority, because you are taking the residents' beach access. Also wanted to be part of the Rail Trail design discussion, especially as it pertains to fencing and planting/irrigation. (Chris Swanner)

Reiterated all the other comments. Verdi should be first priority, and the Mayors newsletter did not include it as a 2018 project. Concerned with SANDAG designs (fence, grainage, vegetation, etc.). (Ed Thielicke)

# CML Working Group (WG) – Notes from Meeting #8 2018-01-09

## Rail Corridor Vision Study - WSP

Council gave direction to the Working Group to further prioritize the 'Phase 1' Crossings.

### South (Cardiff)

- Verdi selected as 1.1
- Birmingham 1.2

- Sanford/Jupiter selected as 1.1
- Phoebe/Glaucus 1.2
- Marcheta/Orpheus 1.3
- Grandview/Hillcrest 1.4

## **Design Guidelines**

The working group discussed various design standards for the Coastal Rail Trail. The group agreed that high level standards are more appropriate since each community desires different types of specific designs. It was discussed and the group understood that these are recommendations and cannot be guaranteed. The following are the working group input results:

- Fence:
- Keep it as close to the tracks as possible throughout the corridor
- Keep it as low and unobtrusive and natural as possible throughout the corridor
- Design input:
  - Allow input and review from community on all phases of the design process (initial concept, 30%, 60%, 90%, and final construction documents)
- Material:
  - Colored concrete with design enhancements (finishes & textures)
- Width
- 12 feet is preferred for the paved multiuse bike path and no center stripe
- Additional features:
  - Enhance the trail with additional landscaping and urban design elements
  - Provide infrastructure to allow for irrigation and lighting
  - Use of reclaimed water and other sustainable design features wherever possible
  - Include additional width for decomposed granite path for pedestrian use where feasible
