### Beacon's Beach Bluff Restoration Project



#### HISTORY

The popular Beacon's Beach access was originally created due to a series of massive landslides. Over the years, further instability in the area damaged stairway structures, with the most recent bluff sloughing occurring in April 2020. Continued erosion events threaten the accessway and recreational safety at this popular beach location. The already unstable cliffs are further exacerbated by heavy foot traffic in the area and the presence of predominantly non-native vegetation. The non-native, annual plants that currently dominate the Project area provide little erosion control.

#### **PROJECT OVERVIEW**

This Project aims to improve soil stability and restore coastal habitat using native vegetation. Planting native vegetation has the additional benefit of improving aesthetics, progressing erosion resilience, and increasing carbon sequestration. After the treatment of existing invasive vegetation, native species will be planted using a combination of potted plants and hydroseed. Supplemental watering will be provided using watering trucks until the vegetation Is established. The project will also include a pilot study using washed up kelp to promote natural dune formation at the bluff base.

#### MONITORING AND COMMUNITY ENGAGEMENT

Long-term maintenance and community engagement are a crucial part of the success of this Project. Beacon's Beach will pilot the new Beach Ambassador program under this Restoration Project.
