The following is in response to my April 16th, 2021 site inspection of the Fenway N Highway 101 Mixed Use Project. This inspection was performed at your request to review the on-site trees at this location and document the species and their condition.

Assignment

Perform physical inventory, collecting tree locations and arboricultural attributes for each tree over 8 inches trunk diameter (12 inches combined trunk diameter for multi-stemmed trees) within the project boundaries. Prepare tree inventory spreadsheet with corresponding map with tree locations. Prepare arborist report with observations and opinions.

Observations

The site consists of a small one-story retail location with a taco shop on the south end of the project. It is in operation and the property is maintained. The north end of the project consists of a closed restaurant with open space around it. It looks to have been closed for some time and no maintenance has been performed on either the restaurant building or the surrounding property.

There are a total of 47 trees within the site location. The south end of the project with the open and operating businesses has a mixture of Queen and Pygmy date palms which are in fair to good condition. North of this location separated by a dirt parking lot has a



mixture of poorly maintained and some trees that have been topped for utility line clearance.

Going up the driveway to the closed restaurant are pine and eucalyptus trees that have not been maintained and are in poor to very poor condition. Around the restaurant are some Queen palms, one King palm and one Pindo palm that are in poor condition. Between the parking area are some large Acacia shrubs, some Giant Bird of Paradise, and one Ficus tree. All are in poor condition except for the Ficus tree which is in fair condition. On the front slope of the project are more eucalyptus and pine trees which are in poor condition.

In front of the project, in the center median of the North Highway 101, are 2 Western Red bud trees in fair to poor condition, 1 Torrey pine in good condition, 1 Coast live oak in poor condition, 1 Monterey Cypress in good condition, and 3 Marina Strawberry trees in good condition.

Opinions and Recommendations

The palm trees around the existing and open businesses, while in fair to good condition, are not high value, rare, or possess heritage tree status. They are easily replaced, and I see no reason to protect in place. Boxing and re-locating is a possibility that could be explored if desired.

The other trees around the property are in poor to very poor condition and are not high value, rare, or possess heritage tree status. None of the trees are worth preserving in place, or worth boxing and re-locating.
