Birmingham Drive Streetscape Project

**Case Nos. MULTI-002718-2017, CDP-002719-2018; and
DR-004386-2021 (17-238 DR/CDP)**

A citizen participation meeting was held on Monday, April 19, 2021 at 6 PM via Zoom Webinar for the Birmingham Drive Streetscape Project.

Purpose

General overview of the project including a summary of the goals, a brief history, major project features, the budget and schedule. The webinar allowed for general questions and input and was recorded.

Communications Focus

- Proposed street cross-section - narrowing of lanes, addition of rain gardens to on both sides of the street, new sidewalk to the north half of the street (west-bound) and addition of bike lane on the east-bound travel way.
- Plant Palette for rain gardens and storm water treatment
- Proposed Gateway sign and its relocation to City property
- Sidewalk Panels – Walk of Fame, 200 panels in various conditions, not ADA compliant
- Roundabout – description and proposed tree at the center
- Undergrounding Utility District – removal of poles along the corridor

Notification Methods

On April 1, 2021, a webinar invitation and information was distributed to all property owners and residents within a 500-foot radius of the Birmingham Drive. In addition, invitations were sent to the local businesses, affect community groups and school district. The invitations were provided in English and Spanish.

A total of 791 notices were mailed, and only 43 mailers were returned. The City of Encinitas provided the mailing list. A total of 86 people registered for the community meeting with 66 people attending. The meeting lasted for two hours.

Materials

A presentation was provided by Julie Ballesteros. The presentation consisted of project exhibits, including the project goals, a brief history, major project features, the budget and schedule.

Captured Commentary

- The roundabout had the most comments and questions (24), with some in support and some questioning its need.
- Preservation of the sidewalk panels was requested throughout and ideas included relocation to a park or the Rail trail and also the idea to offer the same on the new project for fund raising. Some comments were received that they were ok with removal without preservation. Cardiff 101 commented that they would assist with the preservation. 20 comments were documented.
- Traffic Calming was another topic of note with 14 comments/questions. Questions were related to how a roundabout functioned as a traffic calming measure in lieu of a stop sign at the same location. Questions and comments appeared to be 50/50 split in favor vs. opposed.
- 8 questions were related to undergrounding of utilities and removal of specific poles. SDG&E responded.
- Bicyclist safety was another topic which garnered 7 comments/questions. Several were related to the designated bike lane and the need for one. Some felt that it was not safe for bicyclists. Others expressed the need for a designated bike lane in both directions.
- There were questions regarding the rain garden and request for more California native plants. A few comments were related to evaluation and consideration of views with regards to placement of trees.
- Questions arose related to whether the work would encroach unto private property. Some questioned where the easements the City was pursuing were located.
- Lighting was another topic and lighting details were requested.
- The project plans were requested throughout
- One participant objected strongly to the format of not being able to speak. Same participant insisted that another meeting be held in the standard format.

Comments Received Via Email and Phone

Due to the time limitation, not all questions/comments were addressed. We estimate half of the questions/comments were responded to during the meeting. The participants were encouraged to contact the project manager for any additional questions.

In addition to receiving comments at the community meeting, the City received 49 comments via email and provided responses to questions raised by citizens. Attachment 2 provides a summary of the comments received and responses provided.

The roundabout will have signs warning drivers that a roundabout is coming as you come down the hill and then as you come up the hill there will also be a sign there. So they are meant for traffic calming and it is a safety measure. Right now the angle at Newcastle is skewed, so if you're at Newcastle and you're making a left turn to go towards the beach, it's just sight distance issues as it's hard to see a little bit. So this roundabout will improve that in terms of slowing the traffic

The class 1 bike path that Caltrans will be putting in will come to a tee at Birmingham. So you'll be on the southwest corner of the I-5/Birmingham interchange by the gas station. Bikes will come up that hill and they can either go east or west and then continue on to another class 1 bike path just east of the freeway or they would have to legally dismount their bike and walk through the gas station sidewalk and cross the street to go downhill towards the beach or westbound.
22	How do we keep the Cardiff sign as is, with fresh paint?	Dan T	dant64@aol.com	The plan for this project is to relocate the sign. The sign is currently on private property and if we were to maintain it at its location. We have to move it because currently it is in conflict with pedestrian ramps that are slated to be installed at the location of the sign. This is an Americans with Disabilities Act requirement to install ped ramps at that location and to avoid having to obtain an easement for the sign on private property the City is proposing to move it to a location further to the east and it would be on City property in the interest of preserving funds for the project budget.

Give a little background, the existing road curb to curb is about 30 feet so in general we're keeping the same curb alignment as it is. So to put in the retaining walls those are necessary so we can put in the sidewalk so it's not to widen the road. Their length is an average of maybe 50-50 feet long and typically they are about 2-3 feet high so they are not gigantic retaining walls. And they are within the City's right-of-way, none on private property.

The purpose of the tree in the center for everybody to know, Encinitas typically has a tree or trees in the center of all their roundabouts, if you look at Santa Fe Rd and Leucadia Blvd. there are trees in those roundabouts and the purpose is to notify or signal to oncoming traffic that there's an interruption in the drive straight through the kind of intersection to help slow traffic down. So we have to walk that fine balance between getting something large enough that people are gonna see coming from either direction at the roundabout and yet not big enough that's in gonna get in the way of anybody's view. So happy to take a look at that, we can analyze if anybody's view might be blocked and where that might be coming from. So if you have a specific concern or you have a house that you're worried about your view, please contact Julie and the design team would be happy to come out and take a look and try and assess what type of trees we might use to avoid causing a problem for your view.

Paula Jewell	paula.1.jewell@gmail.com	Geoffrey: When we were looking at the cross-section of this, the speed of the bicyclist was taken into account here while keeping the existing width of the road so I'll respond to the 1st comment regarding the 10 foot travel lanes. So with the existing grade of the road, we really wouldn't want a 10 foot lane right next to each other separated by a double yellow center line. Typically we'll put in 10 foot lanes where you have multiple lanes of travel in one direction, so this would be pretty tight going next to each other at the grade of the road. So the 6 foot bike lane uphill was just so that people riding their bikes uphill wouldn't be conflicting with motorists going uphill as there's a very large differential in speed while the 14 foot sharrow lane was meant to be a shared facility between bikes and cars. I just want to point out that the existing lane widths are 15 feet so with no bike facilities. So while we are narrowing that slightly it is still meant to be a shared facility. Roundabouts, speed tables and stop signs were considered as potential traffic control and traffic calming options for the corridor.</p> <ul style="list-style-type: none"> • Roundabouts: Due to right-of-way constraints and the required size of a roundabout, one roundabout was determined to be feasible and is proposed at Birmingham Drive and Newcastle Street. • Speed humps (or speed tables): Vertical deflections such as speed humps or tables are intended to slow speeds on low volume, low speed, and low access roads. As Birmingham Drive is the only City classified circulation element road that's runs east-west in the Cardiff neighborhood, the volume and access requirements of the road are not suitable for speed humps or speed tables. Additionally, installing speed humps on a road with such a steep grade may pose an unexpected hazard to motorists. • All Way Stop: All-way stop signs were considered but determined to be infeasible. In order to maintain existing traffic operations along the corridor the existing side street control is preferred. Installing all-way stop signs will result in increased delay east-west and will result in queuing along the corridor resulting in major impacts to traffic flow, especially in peak travel time hours. <p>The existing width of Birmingham Drive is designed to remain the same for most of the corridor. The street is proposed to be re-striped to narrow the existing travel lanes and install striping provisions for bicyclists (sharrow in the eastbound direction and dedicated bike lane in the westbound direction). The lane narrowing along with the installation of high visibility bicycle markings and high visibility crosswalks is designed to create additional "travel friction" for motorists and to have traffic calming effects, especially in the westbound (downhill) direction where the travel lane is being narrowed from 15-feet to 10-feet. Lastly, the proposed roundabout itself is a traffic calming measure and is designed to slow motorists speeds down to below the posted speed limit on Birmingham Drive approaching and departing the roundabout intersection.</p> <p>Regarding the power lines and poles in the alley between Manchester Ave and Montgomery Ave.: See attached drawing which shows the pole and power line removals in relation to your property. The pole further south in the alley will remain as it is not included in the Undergrounding District. The power lines highlighted in yellow are scheduled to be removed.</p>
