

PROJECT STATUS

Work types performed by Outside Agencies in the City Right-of-way:

- Cable
- Cell Tower
- Fiber Optic
- Power & Natural Gas
- Water & Wastewater

Projects are ongoing and performed on an as-needed basis.

Residents should be notified by the utility company contractors 72-hours prior to start of any work.

The City issues encroachment permits and provides construction inspectors to review quality of repair work.

Asphalt patches are often done in phases (temporary patches and final restoration) for utility trenching.

WORK IN THE UTILITY RIGHT-OF-WAY

Not all work being done in the City of Encinitas utility easements and rights-of-way is conducted by the City.

The City has limited jurisdiction over shared utility easements. Per Federal and State laws and regulations, utility companies have a right to access the utility easements and right-of-way to perform maintenance and upgrades to the utility infrastructure.

The City maintains oversight in the form of issuing encroachment permits and providing contract construction inspectors to ensure work is completed and any repair work on streets and sidewalks is completed to required standards.
