# I-5 Bridge and San Elijo Berm Beach Nourishment Project



#### **HISTORY**

Beach nourishment provides shoreline protection, erosion control, recreational benefits, and habitat enhancement. The City maintains a suite of Sand Compatibility and Opportunistic Use Program (SCOUP) permits. SCOUP permits enable the City to capitalize on opportunities to obtain beach-quality sand from construction, development, or dredging projects in the region and place the materials as beach nourishment. Provided the source materials meet all beach compatibility criteria, salvaged sand can be placed on the beach that would otherwise be disposed of offshore or in a landfill.

#### **PROJECT OVERVIEW**

The Project consists of utilizing a source of sand within the San Elijo Lagoon for beach nourishment at Cardiff State Beach and potentially Moonlight State Beach. The primary source consists of up to 70,000 cubic yards of sand that is currently being used to support the construction of the I-5 Bridge replacement and corridor widening work of Segment 1 of the Caltrans North Coast Corridor project. The 3-acre area located beneath the I-5 is composed of fill material that is a combination of native San Elijo Lagoon marsh sediment and Torrey Sandstone deposits. Most of the material will be dredged and piped to Cardiff State Beach or hauled to Moonlight State Beach.
