Dr. John Nalbandian

John Nalbandian, Professor Emeritus, the faculty in the public ioined administration program at the University of Kansas in the 1970s. U.S. News and World Report ranks the School of Public Affairs and Administration's local government emphasis as the best in the country. John was chair on two occasions. In addition to his administrative experience, John served on the Lawrence, Kansas, City Council for eight years including two terms as the Council's Mayor. John has also served as president of the Lawrence library board and the Willow Domestic Violence Center board, and currently serves on the Lawrence Parks and Recreation Advisory Board, Watkins Museum of History Board, and Friends of the Lied Performing Arts Center. He has received numerous awards for his teaching, research, and service including recognition in Kansas as both academic administrator of the year as well as elected official of the year.

Good Governance

During the retreat, we will debrief some questions about governance where you will be able to lean on your individual and collective experience, as well as on the workshop Dr. Nalbandian will lead.

- Why did you choose to run for elected office why do you serve?
- What do you hope this governing body will be known for?
