Upon signature and return, this correspondence will serve as an amendment to the original contract, executed on August 27, 2014, between the City of Encinitas and Veronica Tam and Associates LLC, regarding ongoing technical assistant and consulting services to facilitate the development of a Housing Element.

This amendment provides for additional scope of services, to include:

- 1. Providing peer review of the Draft Housing Element; and

Dear Mr. Ranu:

Veronica Tam and Associates, Inc. appreciates the opportunity to provide assistance to the City of Encinitas with the Housing Element update.

We are currently contracted for \$9,900 for this assistance. As of August 26, 2015, we have invoiced the City \$8,700.68, with another \$385 to be invoiced at the end of this month, leaving a balance of about \$814. Based on our discussions, we understand that the City would like VTA to continue assisting in the Housing Element process. Specifically, we will provide peer review of the Draft Housing Element, ongoing technical assistance to staff, help facilitate HCD review of the Draft Housing Element, and potentially attend public meetings to address technical questions from the appointed/elected officials and the community.

We are therefore requesting a contract amendment for an additional \$3,000. Services will be provided on a time-and-materials basis at the following rates:
