a. ACTION: Receive Presentation from Fire Chief, Josh Gordon and Captain Christopher Lawrence with San Diego County Sheriff Department

b. Action: Chief Gordon to provide response statistics to committee

c. General Committee discussion on the following items:

- Estimated cost of fire station replacement vs general maintenance/ larger repair costs.
- Current fire response times compared to other cities/national standards.
- Impacts of development and population increase on response time, staffing requirements and ability to respond to potential future 6-7 story buildings. Currently prepared and trained to respond to no higher than 3-story buildings.
- State mandated training and access to training tower, training with live fire, search and rescue, repelling to simulate bluff rescue, high-rise firefighting.
- Busiest (#5) and slowest (#3) stations and response statistics per station. Action: Chief Gordon to provide response statistics to committee.
- City project review for major developments and requirements or findings to confirm sufficient fire service levels for approval; and any associated development service fees to offset costs and address impacts to fire service.
- Top priority facilities Station 6 in Olivenhain to address public safety and prepare for wildland fire threat.
