DIRECTIONS FROM 5 FREEWAY

- 1. Exit **LEUCADIA BLVD**, head west towards the beach
- 2. Make a right on N COAST HWY 101



- 3. Make next **left** on **JASPER ST** (Between Coffee Shop & Surfhouse)
- 4. Make an immediate **right** in the alley behind the coffee shop. Continue to the third building and look for the bright yellow *Live Scan* sign. This is the back of the building and leads to our office. Limited parking is available.

If you are on Coast Hwy101, our office is directly behind The Regal Seagull Restaurant, it can be accessed thru a small courtyard between Paddle Planet on the south of the entryway, and Regal restaurant (north). Look for the bright yellow live scan sign.
