The objectives of the first CAP Update workshop are to foster a clear understanding of why the city is preparing a CAP update, present the greenhouse gas (GHG) inventory and forecasts, highlight the gap in emissions reductions needed to achieve targets, and present preliminary GHG reduction measures to meet these targets.
