- b. ACTION: ITF Discussion and Direction on the following Changes:
  - Direction on Donut Chart Projects: Modify "Criteria 2: Identified Infrastructure Need and Asset Longevity"
    - Modify scoring of Donut Chart projects to receive automatic medium (half points), instead of automatically ranking high (full points).
    - Revert the "Donut Chart" projects back to original ITF ranking; then apply the modified Criteria 2 ranking to increase donut chart projects ranked low up to medium (half points).
    - Kimley Horn to send out reverted/updated project ranking by Friday, Jan. 19<sup>th</sup> and ITF to re-review project ranking and complete updates by Wednesday, Jan. 17<sup>th</sup>.

    - Project Ranking Rubric: Include information on methodology and intent of Rubric and include recommendations for future use of rubric by staff.
