Inherent risk refers to the potential dangers or hazards that are an integral part of a particular activity or environment, regardless of the precautions taken. In the context of agritourism, these risks can stem from various factors.

Pamela Antil City Manager Given these inherent risks, agritourism operators in California must take proactive measures to mitigate potential hazards and ensure the safety of their visitors. The problem with a lack of legislative protection for inherent risk in California, agritourism operations has the potential for increased liability exposure and legal uncertainty for both agritourism operators and visitors.

SB 1479 will provide agritourism professionals with a clear framework that gives both adequate warnings to the public about inherent risks to the activities and reasonable protections from civil liability. Additionally, the bill will ensure consumer protection by

waiving any liability immunity if the agritourism professional failed to meet basic safety precautions. The bill would exempt an agritourism professional from civil liability from injury, loss, damage, or death of a participant of an agritourism activity resulting exclusively from an inherent risk of the activity.
